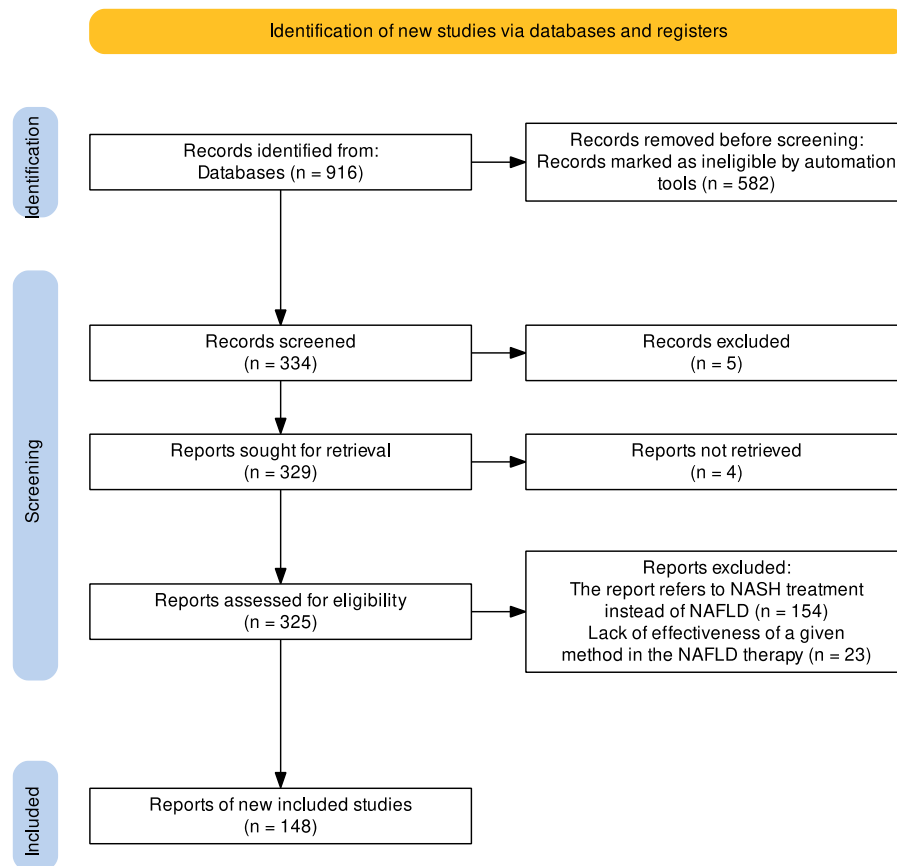


Figure S1. PRISMA diagram of the screening process in the systematic literature review .
