**Purpose:** The purpose of this study is to explore the extent to which universities and university presses are supporting Open Access journals through online journal hosting services and changes in library collections policies. It is hoped that survey results will identify mechanisms of support for Open Access publishing in Canada.

We are therefore conducting an online survey of librarians at university libraries that are members of the Canadian Research Knowledge Network (CRKN), administrators of university presses, and administrators of scholarly presses located at Canadian universities, in order to gather information on Canadian university libraries' and Canadian scholarly presses' level of involvement in hosting online journals and to gather information on their attitudes about future directions in support for open access journals.

**Confidentiality:** The survey software being used anonymizes all responses and does not allow surveys to be identified with the respondent. Survey responses will be kept confidential with respect to the law, and only selected quotations from the survey responses will be published. No quotations or responses will be attributed to named individuals. Quotations will only be attributed by type of respondent and institution: e.g., university press administrator or librarian, large or small university, etc.

Access to survey results stored on computer will be restricted through the use of electronic passwords. Only Donald Taylor, Kumiko Vezina, and the study co-investigators will have access to the data.

As part of the open data initiative, the survey data, in completely anonymized format, will be made openly accessible.

**Privacy:** This online survey was built with the Simon Fraser University survey software tool, and is hosted by Simon Fraser University on servers located in a secure server environment in Burnaby, BC, in compliance with section 30.1 of the BC Freedom of Information and Protection of Privacy Act (FIPPA). All data will be destroyed by the investigators three years after completion of the data analysis. This data will be stored on CD and will be kept in a locked drawer in a secure environment.

**Remuneration/Compensation:** There are no direct benefits to you as a participant of this study. However, your participation will provide valuable information on institutional strategies to support open access, which may prove useful to university libraries and presses across the country.
