Studies that scored a total of 8 or 9 points were considered to have a low risk of bias; 7 or 6 points were considered to have a medium risk of bias; 5 points or less were considered to have a high risk of bias. With respect to selection, studies were considered to have a low, medium or high risk of bias if they scored 4, 2-3 or 1 point, respectively. With respect to comparability, studies were considered to have a low, medium or high risk of bias if they scored 2, 1 or 0 point, respectively. With respect to outcome, studies were considered to have a low, medium or high risk of bias if they scored 3, 2 or 1 point, respectively.
