Type 1 diabetes is a chronic metabolic disease. In recent years, some therapies have greatly improved the glucose control of these patients. However, there are also other metabolic derangements, beyond hyperglycemia, that are involved in the risk of chronic complications of these individuals. In this sense, even in those with good glucose control, the risk of cardiovascular disease is still two-tofour-fold increased. Other factors such lipoprotein resistance-related disturbances. insulin metabolic derangements or obstetric complications could be involved in the risk of vascular complications of these individuals. Notwithstanding, there are still many gaps in the knowledge of the underlying factors involved in micro/macrovascular complications in this disease.

The scope of this special issue is to provide an overview of the recent advances in type 1 diabetes, both in the management of hyperglycemia or other cardiovascular risk factors, as well as in the assessment of vascular complications in this disease.
