Editorial Notes

This issue completes the inaugural year (Volume 1) of the Journal of Theoretical and Applied Electronic Commerce Research. We now look back and recollect the conception of this journal late in 2004, after discussing its creation during the Latino-American Conference on Collaborative Electronic Commerce Technology and Research (2003 & 2004). Setting up JTAER has been demanding in many ways. For authors, writing quality articles, reviewers verifying this quality, editorial board members helping with strategic issues, and the organization of the editorial board, the formation of a reviewers data base, journal logistics, policies, and developing the software to support the submission and publishing processes. We have not finished developing the online submission software yet, but we expect that it will be available during 2007. We know that a new journal matures and improves with time, and we are keen to see it grow, continually striving for new heights. We are very pleased with the quality of content and presentation of the three issues from our first volume, as we have achieved the goals we set for the journal. The next sections will describe some current improvements to policies and guidelines. We close with our achievements and thanks for the year that was 2006.

Change in Policy

You may have noticed that from issue 2, articles published in the journal included the dates the articles were initially received; received in revised form (if applicable); and finally accepted. These dates are important as they show the time taken in the review process. Thanks to our dedicated reviewers we have an effective and efficient reviewing process and papers are published in a timely fashion so that the content remains current.

References Format

Another change that was implemented from issue 2 is the references style which is now based on the IEEE Transaction and Journal references style, but with slight variations that satisfy the journal's requirements. Providing precise guidelines to authors is a difficult task, since the instructions sometimes are subject to interpretation. We have provided exhaustive examples of how to reference books, articles/chapters in a book, journal papers (periodicals), papers in proceedings, papers presented at conferences (unpublished), online sources, thesis or dissertation, reports, manuals, private communications and patents. However, some suggestions from authors are that there is still room for improvement in this area of the journal and we are currently working to address this issue.
