# Circuit Structure and Control Method to Reduce Size and Harmonic Distortion of Interleaved Dual Buck Inverter

#### Abstract

A new circuit structure and control method for a high power interleaved dual-buck inverter are proposed. The proposed inverter consists of six switches, four diodes and two inductors, uses a dual-buck structure to eliminate zero-cross distortion, and operates in an interleaved mode to reduce the current stress of switch. To reduce the total harmonic distortion at low output power, the inverter is controlled using discontinuous-current-mode control combined with continuous-current-mode control. The experimental inverter had a power-conversion efficiency of $98.5 \%$ at output power $=1300 \mathrm{~W}$ and $98.3 \%$ at output power $=2 \mathrm{~kW}$, when the inverter was operated at an input voltage of $400 \mathrm{~V}_{\mathrm{DC}}$, output voltage of $220 \mathrm{~V}_{\mathrm{AC}} / 60 \mathrm{~Hz}$, and switching frequency of 20 kHz . The total harmonic distortion was $<0.66 \%$, which demonstrates that the inverter is suitable for high-power dc-ac power conversion.


Keywords: DC-AC power conversion; inverters; harmonic distortion; low cost

## 1. Introduction

The full-bridge inverter (FBI, Figure 1a) is widely used for dc-ac power conversion because of its simple structure and easy control [1]. An FBI uses sinusoidal modulation of the switching duty to produce an alternating output voltage. The FBI has a shoot-through problem [2], which occurs when the high side and low side switches ( $S_{1}$ and $S_{4}$, or $S_{3}$ and $S_{2}$ ) are turned on at the same time; this problem can cause serious circuit damage. The shoot-through problem can be solved by inserting a dead-time between the gate pulses of the high and low side switches, but inserting a dead-time changes the effective switching duty ratio and increases zero-cross distortion (ZCD) [3]. The FBI has the other disadvantage of requiring high-rated switches and large output filters [4,5].

Various dual-buck inverters [6-15] have been proposed to remedy the disadvantages of the FBI. The dual-buck inverters use freewheeling diodes to solve the shoot-through problem but have high output current ripple. The interleaved dual-buck inverter (IDBI) in [9], as shown in Figure 1b, is basically a parallel connection of four buck converters. In this inverter, $S_{U 1}$ and $S_{U 2}$ operate to generate positive sinusoidal voltage, $S_{D 1}$ and $S_{D 2}$ operate to generate negative sinusoidal voltage, and the switching-phase differences between $S_{U 1}$ and $S_{U 2}$ and between $S_{D 1}$ and $S_{D 2}$ are set to $180^{\circ}$. Thus, the current of $S_{U 1}$ is interleaved with that of $S_{U 2}$, and the current of $S_{D 1}$ is interleaved with that of $S_{D 2}$. Using an interleaved mode reduces conduction losses, output current ripple, and current stress in switches and diodes. IDBI requires four inductors, so it is expensive and bulky. When IDBI uses typical sinusoidal pulse width control and operates at a low output power $P_{0}$, IDBI has much higher total harmonic distortion (THD) of the output current than that of the FBI.

The inverter proposed in this paper (Figure 2) is a modified IDBI. This inverter inherits the IDBI's advantages but uses two reverse-current-protection diodes $D_{D 3}$ and $D_{U 3}$ to reduce the number of inductors and a new control method to reduce the THD of the output current. The proposed inverter operates in discontinuous conduction mode (DCM) [16] when the output current is below the threshold; otherwise, it operates in continuous conduction mode (CCM). The circuit structure and principle of operation are described in Section 2, experimental results and discussions are given in Section 3, and a conclusion is given in Section 4.

## 2. Proposed Interleaved Dual-buck Inverter

### 2.1. Circuit Structure and Principle of Operation

The proposed inverter (Figure 2) uses two dual-buck legs (leg 1: $S_{U 1}, D_{U 1} ; \operatorname{leg} 2: S_{U 2}, D_{U 2}$ ) to generate $V_{\text {grid }} \geq 0 \mathrm{~V}$, two dual-buck legs (leg 3: $S_{D 1}, D_{D 1} ; \operatorname{leg} 4: S_{D 2}, D_{D 2}$ ) to generate $V_{g r i d}<0 \mathrm{~V}$, two blocking diodes $\left(D_{U 3}, D_{D 3}\right)$ to prevent the current flowing through the body diode of switch during freewheeling mode, and two unfolding switches $\left(S_{U 3}, S_{D 3}\right)$ to determine the polarity of the output current. Legs 1 and 4 are connected to $L_{1}$, and legs 2 and 3 are connected to $L_{2}$. Therefore, the proposed inverter requires two inductors, unlike interleaved dual-buck inverters, which have four legs and one inductor per leg. The proposed inverter works with the switching states and leg voltages $V_{A N \_o n}$ and $V_{A N \_o f f}$ in Table 1. Leg switches $S_{U 1}, S_{U 2}, S_{D 1}$, and $S_{D 2}$ operate at a fixed switching frequency $f_{s}=1 / T_{s}$, where $T_{s}$ is the switching period. The switching duty $D$ is varied to produce a sinusoidal output voltage $V_{\text {grid }}(t)=V_{g} \sin (\omega t)$.

The simplified gate signals (Figure 3) for the proposed inverter show that legs 1 and 2 operate for $V_{\text {grid }}>0 \mathrm{~V}$ and legs 3 and 4 operate for $V_{\text {grid }}<0 \mathrm{~V}$. $S_{U 3}$ turns for $V_{\text {grid }} \geq 0 \mathrm{~V}$ and $S_{D 3}$ turns on for $V_{\text {grid }}$ $<0 \mathrm{~V}$. To obtain interleaved dual-buck operation, the switching phase differences between $S_{U 1}$ and $S_{U 2}$ and between $S_{D 1}$ and $S_{D 2}$ are set to $T_{s} / 2$. The difference in switching phases reduces ZCD and prevents shoot-through without inserting dead time between switching pulses (Table 1).

When $V_{\text {grid }}>0 \mathrm{~V}$, the current $i_{L 1}$ and voltage $V_{L 1}$ waveforms of the inductor $L_{1}$ (Figure 4a) consist of three operating modes: Mode 1 during which the input energy is delivered to $L_{1}$ and the load; Mode 2 during which the stored energy in $L_{1}$ is delivered to the load; and Mode 3 during which the stored energy in $L_{1}=0$; Mode 3 occurs only when the inverter operates in DCM.

Mode 1 starts at $t_{0}=(n-1) T_{s}$ by turning on $S_{U 1}$ (Figure 4 b ), where the integer $n$ is a switching sequence number. During this mode, the output voltage $V_{A N}$ of leg 1 is $V_{\text {in }}$. The inductor current $i_{L 1}(t)$ increases as $t$ increases, because $V_{L 1}=V_{A N}-V_{\text {grid }}>0 \mathrm{~V}$ and

Mode 2 starts at $t_{1}=(n-1+D) T_{S}$ by turning off $S_{U 1}$ (Figure 4 c ). During this mode, $V_{A N}$ is 0 V . $i_{L 1}(t)$ decreases as $t$ increases because $V_{L 1}=V_{A N}-V_{\text {grid }}<0 \mathrm{~V}$ and

Mode 3 starts at $t_{2}=(n-1+\Delta) T_{s}$ where $\Delta T_{s}$ is duration of $i_{L 1}(t)>0$, when $D_{U 1}$ is turned off (Figure 4 d ). This mode is skipped when $\Delta=1$, i.e., when the inverter is operating in CCM. During this mode, $V_{A N}=V_{\text {grid }}$ because $i_{L 1}(t)=0$ and the energy stored in $L_{1}$ is 0 .

The voltage $V_{A N}$ of node A with respect to node N equals to $V_{g r i d}+V_{L 1}(t)$. The switching states (Table 1) produce $V_{A N}=V_{i n}$ in Mode 1, $V_{A N}=0 \mathrm{~V}$ in Mode 2, and $V_{A N}=V_{g r i d}$ in Mode 3. The average of $V_{A N}$ for one switching period is expressed as

$S_{U 1}$ operates with a switching duty of $D=D_{S U 1} . V_{A N \_a v g}$ can also be expressed as

because $V_{A N}=V_{\text {in }}$ in Mode 1, $V_{A N}=0 \mathrm{~V}$ in Mode 2, and $V_{A N}=V_{\text {grid }}$ in Mode 3. Solving for $\Delta$ using (3) and (4) yields

To achieve a power factor of 1 , the time average of output current $i_{o \_ \text {avg }}$ should be $I_{0} \sin (\omega t)$ for $V_{\text {grid }}(t)=V_{g} \sin (\omega t)$. The inverter has $L_{1}=L_{2}=L$ and operates in interleaved dual-buck mode,
so $i_{0 \_a v g}=2 i_{L 1 \_a v g}$. When the inverter operates in DCM, $D_{S U 1}$ at $t=t_{0}$ to produce sinusoidal $i_{o \_a v g}$ is obtained using Equations (5) and (6), $2 \pi f_{s} \gg \omega$ and $i_{L 1}\left(t_{0}\right)=0$ as

When the inverter is operating in $C C M, \Delta=1$ and $D_{S U 1}$ at $t=t_{0}$ is obtained using Equation (5) as

The DCM interval during which the inverter operates in DCM is calculated using Equations (5), (7), and $\Delta \leq 1$ as

when $V_{\text {grid }}$ decreases.
The condition for operating the inverter only in CCM is obtained by setting the argument of arcsine in Equations (9) and (10) less than 0, and is given as

and the condition for operating the inverter only in DCM is obtained by setting the argument of arcsine in Equations (9) and (10) greater than 1, and is given as

The waveforms $i_{L 2}$ and $V_{L 2}$ of the inductor $L_{2}$ for $V_{\text {grid }}>0 \mathrm{~V}$ are the same as $i_{L 1}$ and $V_{L 1}$ except that they are delayed by $T_{S} / 2$.

The waveforms $i_{L 1}, V_{L 1}, i_{L 2}$, and $V_{L 2}$ for $V_{g r i d}<0 \mathrm{~V}$ are identical to the waveforms $i_{L 2}, V_{L 2}, i_{L 1}$, and $V_{L 1}$ for $V_{\text {grid }}>0 \mathrm{~V}$, respectively, except that the polarity is reversed.

### 2.2. Design Constraint for $L_{1}$ and $L_{2}$

The inverter must operate at $I_{0} \leq I_{o, \max }$. The highest switching duty $D_{S U 1 \_\max }$ of $S_{U 1}$ is calculated using Equation (8) as

which results in the upper bound of $L_{1}=L_{2}=L$ as

This condition gives $L<103.44 \mathrm{mH}$ when $P_{o}=2 \mathrm{~kW}$ and $I_{O_{-} \max }=12.9 \mathrm{~A}$.

The current and voltage waveforms for $L_{2}$ are same as those for $L_{1}$, except the time delay by $T_{S} / 2$; hence, the output current ripple $i_{o_{-} \text {ripple }}$ of the proposed inverter can be calculated using Equations (1), (2) and (8) as

for $1 / 2<D<1$; the highest $i_{o_{0} \text { ripple }}$ occurs at $D=1 / 4$ or $3 / 4$. After allowing the highest $i_{o \_ \text {ripple }}$ of 1 A at $P_{o}=2 \mathrm{~kW}$ and $f_{s}=20 \mathrm{kHz}$ (this condition corresponds to THD $<3 \%$ ), the lower bound of $L$ is obtained using Equations (15) and (16) as

$L_{\min }=2.5 \mathrm{mH}$ was used in the experimental inverters to minimize the inductor size.

### 2.3. Controller Design

The controller (Figure 5) was designed using Texas Instrument's TMS320F28335 digital signal processor (DSP). This controller inputs $V_{\text {grid, }}, i_{o \_ \text {avg }}$, and $V_{i n}$ and uses the D-Q axis control method [17] to produce gating signals $S_{U 1}-S_{U 3}$ and $S_{D 1}-S_{D 3}$ that can generate a sinusoidal $i_{o_{-} a v g}$. The controller consists of a phase-locked loop (PLL), a D-Q axis controller, and a gate pulse generator. The DSP operates at a clock frequency $f_{c l k}=1 / T_{c l k}=150 \mathrm{MHz}$ and the sampling frequency is the same as the switching frequency $f_{\mathrm{s}}=1 / T_{s}=20 \mathrm{kHz}$. Thus, the sampling sequence number $n$ is in the range of $0 \leq n \leq 332$ when the grid frequency $f=\omega / 2 \pi=60 \mathrm{~Hz}$, and clock sequence number $j$ is in the range of $0 \leq j \leq 7499$.

The PLL (Figure 6) sets $n=0$ and starts to operate when $V_{\text {grid }}=0$ and the enable signal $\mathrm{EN}=1$. This circuit inputs $V_{\text {grid }}$ and estimates the amplitude $V_{g}$ and phase $\hat{\theta}=\hat{\omega} t$ of $V_{\text {grid }}$. Using $V_{\text {grid }}[n]=V_{g} \sin (\theta[n])$, the PLL generates a virtual grid-voltage $V_{\text {grid_qs }}$ as

$\hat{\theta}[0]$ has been set to 0 if $V_{\text {grid_qs }}[0] \geq 0$ and to $\pi$ otherwise. Thus, the initial estimation error $e_{\theta}[0]=\theta[0]-\hat{\theta}[0]$ is very small. $V_{g r i d}$ and $V_{\text {grid_qs }}$ are transformed into the voltages $V_{\text {grid_d }}$ and $V_{g r i d \_q}$ in the synchronous reference frame as

when $\hat{\theta}[n] \approx \theta[n], V_{g}$ and $e_{\theta}[n]=\theta[n]-\hat{\theta}[n]$ can be calculated using Equations (20) and (21). The PLL loop filter for a proportional-integral (PI) control produces

in the $s$-domain, where $s$ is the complex frequency. The final value theory $\lim _{s \rightarrow 0} s \hat{\theta}(s)=\lim _{t \rightarrow \infty} \hat{\theta}(t)$ of the Laplace transform yields $\lim _{t \rightarrow \infty} \hat{\theta}(t)=\lim _{t \rightarrow \infty} \theta(t)$, i.e., $\hat{\theta} \approx \theta=\omega t$ under steady state. $\left(k_{p}=2000\right.$ and $k_{i}=0.1$ have been chosen for the experimental inverter; these values result in at a zero at $\mathrm{s}=-0.00005$ and two poles at $\mathrm{s} \approx-0.00005$ and -2000 , so the loop filter operates as a first-order system with a cutoff frequency $f_{c} \approx 2000 / 2 \pi \mathrm{~Hz}=f_{s} / 20 \pi \approx 5 \times 60 \mathrm{~Hz}$.)

The D-Q axis controller (Figure 7) consists of a CCM duty-calculator and a duty compensator. The CCM duty-calculator inputs $i_{o-a v g}$ and $V_{i n}$ from the inverter, and $\hat{\theta}$ and $V_{g}$ from the PLL. In the CCM duty-calculator, $i_{o_{-} a v g}=i_{o_{-} d s}$ is delayed by $\pi / 2$ to obtain the virtual current $i_{o_{-} q s}$ of $i_{o \_a v g}$. The D-Q transformation separates $i_{o_{-} a v g}$ into a D component $I_{o_{-} d}$ parallel to the grid voltage and a Q component $I_{o_{-} q}$ orthogonal to the grid voltage:

For given $I_{0_{-} d}$ and $I_{O_{-} q}$, the circuit topology results in the D-Q components of $V_{A N}$ in the synchronous reference frame as

because $V_{A N_{-} d}=V_{i n} D_{d}$ and $V_{A N_{-} q}=V_{i n} D_{q}$. The D-Q axis controller inputs $I_{o_{-} d_{-} r e f}$ and $I_{O_{-q}-r e f}$ as the reference values of $I_{O_{-} d}$ and $I_{o_{-} q}$, respectively, and calculates the errors $e_{d}[n]=I_{o_{-} d \_r e f}-I_{O_{-} d}$ and $e_{q}[n]=I_{o_{-q} r e f}-I_{o_{-} q}$. Then, the controller generates the D-Q components of the switching duty for CCM operation:

Both D and Q components have equivalent closed-loop transfer function in the $s$-domain as

$k_{p}=5$ and $k_{i}=25$ have been chosen for the $H(s)$ of the experimental inverter. These values result in a zero at $\mathrm{s}=-5$ and two poles at $\mathrm{s} \approx-5.012, \mathrm{~s} \approx-1944.99$. The zero at $s=-5$ is close enough to cancel the pole at $s \approx-5.012$; hence, $H(s)$ operates like a first-order system with a cutoff frequency $f_{c} \approx 2000 / 2 \pi$ $\mathrm{Hz}=f_{s} / 20 \pi \approx 5 \times 60 \mathrm{~Hz}$ [18].

To operate the inverter with a power factor of 1 , the reference inputs must be $I_{O_{-} d \_r e f}=I_{o}=2 P_{o} / V_{g}$ and $I_{o_{-} q_{-} r e f}=0$; therefore, $I_{o_{-} d} \rightarrow I_{o_{-} d_{-} r e f}=I_{o}$ and $I_{o_{-} q} \rightarrow I_{o_{-} q_{-} r e f}=0$ under steady state. Thus, the inverse D-Q transform produces the switching duty $D_{C C M}$ for CCM operation as

The duty compensator inputs $V_{i n}$ from the inverter, $\hat{\theta}$ and $V_{g}$ from the PLL, and $I_{o_{-} d_{-} r e f}$ from CCM duty-calculator. Then, the compensator uses in Equations (7) and (8) to calculate the steady-state duty difference $\Delta D$ between the switching duties for CCM and DCM operations. $\Delta D$ is given by

This equation shows that the switching duty in Equation (7) for DCM operation is always smaller than the one in Equation (8) for CCM operation. Thus, the controller uses $D_{S U 1}[n]=D[n]=D_{C C M}[n]+$ $\Delta D[n]$ when $\Delta D[n]<0$, and the inverter operates in DCM. Otherwise, the controller sets $\Delta D[n]=0$, and the inverter operates in CCM.

The gate pulse generator (Figure 8) inputs $D_{S U 1}$ form the D-Q axis controller and generates gate pulses for $S_{U 1}-S_{U 3}$ and $S_{D 1}-S_{D 3}$. In the gate pulse generator, two saw-tooth-signals $S_{c}[j]$ and $S_{c p}[j]$ are generated using two 16 -bit up/down (U/D) counters; at each clock (clk) edge, the outputs $S_{c}[j]$ and $S_{c p}[i]$ of $\mathrm{U} / \mathrm{D}$ counters increase by 1 when $\mathrm{U} / \mathrm{D}=\mathrm{UP}$ and decrease by 1 when $\mathrm{U} / \mathrm{D}=\mathrm{DOWN}$. Initial values of saw-tooth signals are $\mathrm{Sc}[0]=0, \mathrm{Scp}[0]=\mathrm{Ts} /(2 \mathrm{Tclk}), \mathrm{U} / \mathrm{D} 1[0]=\mathrm{UP}$, and U/D2[0] $=\mathrm{DOWN}$ to yield an interleave operation.

At each clock edge, $S_{c}[j]$ increase by 1 for $n T_{s} \leq t<(n+(1 / 2)) T_{s}$ during which U/D $D_{1}$ is UP, and $S_{c}[j]$ decreases by 1 for $(n+(1 / 2)) T_{s} \leq t<(n+1) T_{s}$ during which $\mathrm{U} / \mathrm{D}_{1}$ is DOWN. When $S_{c}[j]<0, \mathrm{U} / \mathrm{D}_{1}$ changes to UP and the next sequence begins. $S_{c p}[j]$ decreases by 1 for $n T_{s} \leq t<(n+(1 / 2)) T_{s}$ during which $\mathrm{U} / \mathrm{D}_{2}$ is DOWN, and $S_{c p}[j]$ increases by 1 for $(n+(1 / 2)) T_{s} \leq t<(n+1) T_{s}$ during which $\mathrm{U} / \mathrm{D}_{2}$ is UP. $\mathrm{U} / \mathrm{D}_{2}$ changes to DOWN when $S_{c p}[j]<0$, and the next sequence begins. Thus, $S_{c p}[j]$ is a time-delayed
signal of $S_{c}[j]$ by $T_{s} / 2$, the maximum values of $S_{c}[j]$ and $S_{c p}[j]$ are $T_{s} /\left(2 T_{c l k}\right)$, and the minimum values of $S_{c}[j]$ and $S_{c p}[j]$ are 0 . To generate PWM signals using the saw-tooth signals, a reference signal $R_{h}[n]$ is generated using $D_{S U 1}$ and $T_{s} /\left(2 T_{c l k}\right)$ as

$R_{h}[n]$ is stored in the shadow register of the PWM generation module in TMS320F28335 and transferred to the comparator reference-input $\operatorname{Ref}[n]$ when $S_{C}[j]=0$. Two comparators check the sign of $V_{\text {grid }}[n]: C_{3}=1$ and $C_{4}=0$ for $V_{\text {grid }}[n] \geq 0$, otherwise $C_{3}=0$ and $C_{4}=1$ (Table 2). The other comparators output two PWM signals: $C_{1}=1$ for $\operatorname{Ref}[n]>S_{c}[j]$ and $C_{2}=1$ for $\operatorname{Ref}[n]>S_{c p}[j]$. Finally, the logic gates produce gate control pulses $S_{U 1}=C_{1} \cdot C_{3}, S_{U 2}=C_{2} \cdot C_{3}, S_{U 3}=C_{3}, S_{D 1}=C_{1} \cdot C_{4}, S_{D 2}=C_{2} \cdot C_{4}$, and $S_{D 3}=C_{4}$.

## 3. Experimental Results and Discussions

The proposed inverter (Figure 9a, Table 3) was designed to operate at $V_{\text {in }}=400 \mathrm{~V}_{\mathrm{DC}}$, $V_{\text {grid }}=220 \mathrm{~V}_{\mathrm{AC}} / 60 \mathrm{~Hz}$ and $150 \mathrm{~W} \leq P_{o} \leq 2 \mathrm{~kW}$, and it was fabricated and tested using the calculated circuit parameters. An IDBI [9] (Figure 9b, Table 3) and an FBI [1] (Figure 9c, Table 3) were also fabricated and tested for comparison; the circuit elements for these inverters were the same as those for the proposed inverter. The control circuits for all experimental inverters were implemented using the TMS320F28335 digital signal processor (DSP) from Texas Instruments.

The proposed inverter uses two inductors, whereas the IDBI uses four inductors, and the proposed inverter uses a small inductor core (EER6062), whereas the FBI uses a large inductor core. The fabricated inverters had a circuit volume of $160 \mathrm{~mm} \times 250 \mathrm{~mm} \times 43.9 \mathrm{~mm}$ for the proposed inverter, $450 \mathrm{~mm} \times$ $550 \mathrm{~mm} \times 43.9 \mathrm{~mm}$ for the IDBI, and $380 \mathrm{~mm} \times 550 \mathrm{~mm} \times 78.0 \mathrm{~mm}$ for the FBI; the proposed inverter reduced $83.8 \%$ of the circuit volume compared with the IDBI, and $89.3 \%$ compared with the FBI. The circuit cost was $\$ 71.04$ for the proposed inverter, $\$ 77.74$ for the IDBI, and $\$ 73.9$ for the FBI; the proposed inverter saved $8.62 \%$ of the circuit cost compared with the IDBI, and $3.87 \%$ compared with FBI.

To verify operation of the proposed inverter, the waveforms of switch-control pulses (Figure 10a) were measured at Vin $=400 \mathrm{VDC}, V_{\text {grid }}=220 \mathrm{~V}$ AC $/ 60 \mathrm{~Hz}, P_{o}=2 \mathrm{~kW}$, and $f_{s}=20 \mathrm{kHz}$. These waveforms show that the switches operated according to the switching states in Table 1; when $V_{\text {grid }}>0 \mathrm{~V}, S_{U 1}$ and $S_{U 2}$ operated in PWM mode, $S_{U 3}$ stayed ON and other switches stayed OFF; when $V_{\text {grid }}<0 \mathrm{~V}, S_{D 1}$ and $S_{D 2}$ operated in PWM mode, $S_{D 3}$ stayed ON and other switches stayed OFF. The inductor currents $i_{L 1}$ and $i_{L 2}$, and the leg voltages $V_{G S \_S U 1}$ and $V_{G S \_S U 2}$ (Figure 10b) show that the inverter operated in an interleaved mode; the phase differences between $i_{L 1}$ and $i_{L 2}$, and between $V_{G S \_S U 1}$ and $V_{G S \_S U 2}$ were $T_{s} / 2$. These switching states produced the sinusoidal leg voltage $V_{A N}$ (Figure 10c).
$\eta_{e}$ vs. $P_{o}$ (Figure 11) was measured at $V_{i n}=400 \mathrm{~V}_{\mathrm{DC}}, V_{\text {grid }}=220 \mathrm{~V}_{\mathrm{AC}} / 60 \mathrm{~Hz}, 150 \mathrm{~W} \leq P_{o} \leq 2 \mathrm{~kW}$, and $f_{s}=20 \mathrm{kHz}$ and 40 kHz , using a PW3336 (HIOKI E.E. Co.) power meter. At $f_{s}=20 \mathrm{kHz}$, the proposed inverter had $\eta_{e}>98 \%$ for $P_{o} \geq 500 \mathrm{~W}$, but $\eta_{e}$ for $P_{o}<500 \mathrm{~W}$ decreased as $P_{o}$ decreased because the inverter operated in DCM. The highest power conversion efficiency $\eta_{\text {emax }}$ of the proposed inverter was $98.5 \%$ at $P_{o}=1300 \mathrm{~W}$ when the power loss $P_{D S P}$ of the gate control/drive circuit was included. ( $\eta_{\text {emax }}=99.2 \%$ at $P_{o}=500 \mathrm{~W}$ when $P_{D S P}$ was excluded.) The FBI does not use the interleaved buck inversion; hence, the switching and conduction losses in the current path were higher in the FBI than in the proposed inverter; as a result, the FBI had the lowest $\eta_{e}$ among the inverters tested. The IDBI has a circuit structure similar to the proposed inverter and operates in interleaved mode, so $\eta_{e}$ of the IDBI was very close to that of the proposed inverter. However, the proposed inverter requires two
inductors to operate the inverter in interleaved mode, while the IDBI requires four inductors; hence, the proposed inverter can be implemented in a smaller size.

Losses (Figure 12) of the experimental inverters were analyzed at $V_{i n}=400 \mathrm{~V}_{\mathrm{DC}}$, $V_{\text {grid }}=220 \mathrm{~V}_{\mathrm{Ac}} / 60 \mathrm{~Hz}, f_{s}=20 \mathrm{kHz}, P_{o}=2 \mathrm{~kW}$ and 150 W , and reactive output power $Q_{o}=0$ volt-ampere-reactive (VAR). The switching losses $P_{S W}$ were 13.2 W for proposed, 13.89 W for IDBI,
and 29.71 W for FBI at $P_{o}=2 \mathrm{~kW}$, and $P_{S W}$ were 2.18 W for proposed, 2.48 W for IDBI, and 8.42 W for FBI at $P_{o}=150 \mathrm{~W}$. The inverters operated at $V_{S W}=V_{i n}$ and $N_{S W}=666$ for proposed and IDBI, and $V_{S W}=V_{\text {in }}$ and $N_{S W}=1333$ for FBI, where $N_{s w}$ is the total switching number for one cycle of $V_{\text {grid }}$. Thus, the proposed inverter and IDBI had the lowest $P_{S W}$. The inductor loss $P_{\text {IND }}$ was 9.25 W for proposed, 10.33 W for IDBI, and 66.32 W for FBI at $P_{o}=2 \mathrm{~kW}$ and 0.155 W for proposed, 0.162 W for IDBI, and 0.66 W for FBI at $P_{o}=150 \mathrm{~W}$. The proposed inverter uses interleaved inputs; hence, the inductor current $i_{L}$ is half of the $i_{L}$ of FBI. Moreover, the proposed inverter uses small inductors with fewer turns than that of the FBI. Thus, FBI had the highest $P_{I N D}$. The diode loss $P_{D}$ was 7.04 W for proposed, 6.45 W for IDBI, and 0 for FBI at $P_{o}=2 \mathrm{~kW}$, and $P_{D}$ was 0.907 W for proposed, 0.885 W for IDBI, and 0 for FBI at $P_{o}=150 \mathrm{~W}$. The power loss $P_{D S P}$ of the gate control/drive circuit was 6.02 W for proposed, 6.19 W for IDBI, and 6.48 W for FBI at both $P_{o}=150 \mathrm{~W}$ and $P_{o}=2 \mathrm{~kW}$. The total power loss $P_{\text {loss }}$ at $P_{o}=2 \mathrm{~kW}$ was 35.53 W for proposed, 36.87 W for IDBI, and 102.51 W for FBI, and the power conversion efficiency $\eta_{e}$ at $P_{o}=2 \mathrm{~kW}$ was $98.2 \%$ for proposed, $98.1 \%$ for IDBI, and $94.9 \%$ for FBI. $P_{\text {loss }}$ at $P_{o}=150 \mathrm{~W}$ was 9.279 W for proposed, 9.717 W for IDBI, and 15.5 W for FBI, and $\eta_{e}$ at $P_{o}=150 \mathrm{~W}$ was $93.8 \%$ for proposed, $93.5 \%$ for IDBI, and $89.6 \%$ for FBI.

The temperature $T_{S W}$ of switch vs. time of operation (Figure 13) was measured while operating the experimental inverters at $V_{\text {in }}=400 \mathrm{~V}_{\mathrm{DC}}, V_{\text {grid }}=220 \mathrm{~V}_{\mathrm{AC}} / 60 \mathrm{~Hz}, P_{o}=2 \mathrm{~kW}$, and $f_{s}=20 \mathrm{kHz} . T_{S W}$ was stabilized at $\sim 52{ }^{\circ} \mathrm{C}\left(S_{U 1}, S_{U 2}, S_{D 1}, S_{D 2}\right)$ and $\sim 55^{\circ} \mathrm{C}\left(S_{U 3}, S_{D 3}\right)$ in the proposed inverter, $\sim 54{ }^{\circ} \mathrm{C}$ $\left(S_{U 1}, S_{U 2}, S_{D 1}, S_{D 2}\right)$ and $\sim 58^{\circ} \mathrm{C}\left(S_{U 3}, S_{D 3}\right)$ in the IDBI, and at $\sim 110^{\circ} \mathrm{C}$ in FBI. $P_{S W}$ at $P_{o}=2 \mathrm{~kW}$ were 13.2 W for proposed, 13.89W for IDBI, and 29.71 W for FBI; therefore, $T_{s w}$ of the proposed inverter and IDBI was half that of FBI.

THD of $i_{0}$ vs. $P_{o}$ (Figure 14) was also measured at $V_{\text {in }}=400 \mathrm{~V}_{\mathrm{DC}}, V_{\text {grid }}=220 \mathrm{~V}_{\mathrm{AC}} / 60 \mathrm{~Hz}, P_{o}=150 \mathrm{~W}$ $\sim 2 \mathrm{~kW}$, and $f_{s}=20 \mathrm{kHz}$. THD at $P_{o}=2 \mathrm{~kW}$ was $0.66 \%$ for proposed and IDBI and $3.25 \%$ for FBI; FBI had the highest THD because this inverter produced a ZCD during the dead-time period. THD at $P_{o}=150 \mathrm{~W}$ was $16.6 \%$ for IDBI and the proposed inverter when the switching duties for the inverters were controlled using the CCM control (given in (8)). At a low $P_{0}$, the proposed inverter operated in DCM for some time-interval of sinusoidal $V_{\text {grid }}$, as discussed in Section 2.2. This operation produced a distortion in $I_{0}$ when the inverters were operated under CCM control only.

When the switching duties for IDBI and the inverters were controlled using the proposed DCM +CCM control (a combination of the CCM control and the DCM control given in Equation (7)), the THD at $P_{o}=150 \mathrm{~W}$ was reduced to $4.1 \%$ because the combined $\mathrm{DCM}+\mathrm{CCM}$ control reduced the distortion in $I_{0}$ significantly.

When $f_{s}$ was increased to 40 kHz , THD of $i_{o}$ at $P_{o}=2 \mathrm{~kW}$ was $0.63 \%$ for proposed and IDBI and $7.24 \%$ for FBI. The FBI nearly doubled the THD at $f_{s}=40 \mathrm{kHz}$ compared to the value at $f_{s}=20 \mathrm{kHz}$, because the change increased the effect of dead-time on the switching duty. The THD at $P_{o}=150 \mathrm{~W}$ was $7.41 \%$ for the proposed inverter using CCM control, $3.98 \%$ for the proposed inverter using DCM + CCM control, and $3.51 \%$ for FBI. The DCM operating time was reduced at higher $f_{s}$ (Equations (9) and (10)); hence, THD of the proposed inverter decreased as $f_{s}$ increased; a DCM control near the zero crossing point increased $i_{L}$. In contrast, the THD for FBI increased as $f_{s}$ increased because the impact of dead-time on the switching duty increased.

The waveforms of $i_{0}$ and $i_{0 \_a v g}$ for the experimental inverters (Figure 15) were measured at $V_{\text {in }}=400 \mathrm{~V}_{\mathrm{DC}}, V_{\text {grid }}=220 \mathrm{~V}_{\mathrm{AC}} / 60 \mathrm{~Hz}, f_{s}=20 \mathrm{kHz}, P_{o}=150 \mathrm{~W}, Q_{o}=0 \mathrm{VAR}$, and $I_{o}=0.95 \mathrm{~A}$. The cutoff frequency of the low-pass filter for $i_{o_{-}}$avg measurement was $2 \mathrm{kHz}\left(=f_{s} / 10\right)$. The inverters were controlled using CCM or DCM+CCM control. The waveforms of $i_{o}$ show that the proposed inverter had the lowest switching ripple of $i_{o}$, and the waveforms of $i_{o_{-} a v g}$ show that the DCM +CCM control of the proposed inverter achieved the best sinusoidal waveform. The harmonic components of $i_{o}$ (Figure 16) show that harmonics of $i_{0}$ of FBI were slightly higher than those of the proposed inverter because the proposed inverter operated as an interleaved dual buck inverter.

The dynamic responses of the proposed inverter (Figure 17) were measured for a step change of $P_{o}$ from 2 kW to 1 kW and a step change of $P_{o}$ from 1 kW to 2 kW ; the operating conditions for this measurement were $V_{\text {in }}=400 \mathrm{~V}_{\mathrm{DC}}, V_{\text {grid }}=220 \mathrm{~V}_{\mathrm{AC}} / 60 \mathrm{~Hz}, f_{s}=20 \mathrm{kHz}$, and $Q_{o}=0$ VAR. For both $P_{0}$ changes, the output current $i_{0}$ did not overshoot, and the transient time of $i_{0}$ was $<2 \mathrm{~ms}$, which is $\sim 1 / 8$ of the sinusoidal period at 60 Hz . PF, THD, and $i_{0}$ of the proposed inverter were measured for $P_{o}=666.6 \mathrm{~W}, 1.333 \mathrm{~kW}$, and 2 kW at $V_{\text {in }}=400 \mathrm{~V}_{\mathrm{DC}}, V_{\text {grid }}=220 \mathrm{~V}_{\mathrm{AC}} / 60 \mathrm{~Hz}, f_{s}=20 \mathrm{kHz}$, and line impedance $\mathrm{Z}=0.4+\mathrm{j} 0.25 \Omega$. The measured PF was 0.9973 at $P_{o}=666.6 \mathrm{~W}(33 \%$ of the rated power $)$, 0.9985 at $P_{o}=1.333 \mathrm{~kW}(66 \%$ of the rated power $)$, and 0.9992 at $P_{o}=2 \mathrm{~kW}(100 \%$ of the rated power $)$. The measured THD of $i_{0}$ was $4.20 \%$ at $P_{o}=666.6 \mathrm{~W}, 3.68 \%$ at $P_{o}=1.333 \mathrm{~kW}$, and $3.43 \%$ at $P_{o}=2 \mathrm{~kW}$. These results fulfill most grid-connected inverter standards for renewable energy [19-22].

Comparisons (Table 4) of the circuit parameters and experimental results demonstrate the superiority of the proposed inverter. The proposed inverter has the following advantages: (1) proposed inverter requires two inductors, whereas IDBI requires four inductors; hence, the proposed inverter can be implemented with lower cost and smaller volume than IDBI; (2) it uses interleaved operation, which reduces the current stress of the switch by $1 / 2$ of that in FBI; (3) the number of switching for one period of $V_{\text {grid }}$ in the proposed inverter is $1 / 2$ of that in FBI; hence, the switching loss is reduced; and
(4) $\eta_{e}$ at $P_{o}=2 \mathrm{~kW}$ is as high as $98.3 \%$, compared to $95.0 \%$ for FBI. These advantages indicate that the proposed inverter is useful for high-power dc-ac power conversion.

## 4. Conclusions

This paper proposes an inverter that can achieve high power conversion efficiency $\eta_{e}$ at high output power $P_{o}$. The inverter uses a dual-buck structure to eliminate zero-cross distortion, operates in an interleaved mode to reduce the current stress of switch, and uses DCM + CCM combined control to reduce the output current distortion at low output power. The size and weight of the circuit are reduced by decreasing the number of inductors and by using blocking diodes; the proposed inverter could reduce $83.8 \%$ of the circuit volume compared with IDBI and $89.3 \%$ compared with FBI, and it could save $8.62 \%$ of the circuit cost compared with IDBI and $3.87 \%$ compared with FBI. When the experimental inverter was operated at an input voltage of $400 \mathrm{~V}_{\mathrm{DC}}$, an output voltage of $220 \mathrm{~V}_{\mathrm{AC}} / 60$ Hz , and switching frequency of $20 \mathrm{kHz}, \eta_{e}$ was $>94 \%$ at $150 \mathrm{~W} \leq P_{o} \leq 2 \mathrm{~kW}, 98.5 \%$ at $P_{o}=1300 \mathrm{~W}$, and $98.3 \%$ at $P_{o}=2 \mathrm{~kW}$. The total harmonic distortion was $0.66 \%$ at $P_{o}=2 \mathrm{~kW}$. The proposed inverter is well-suited for high power dc-ac power conversion.
