An updated organization chart of the City Council must be published, a list identifying the persons responsible for the administrative units, the identification of the "persons responsible for the different bodies" is required, being understood as the persons responsible for the different areas of operation of the City Council, all the personnel coming from the instrumental entities must be included and the profile and professional trajectory of the persons responsible who hold the consideration of high office must be included, in accordance with Law 3/2015, of March 30, regulating the exercise of senior positions in the General Administration of the State, or have the status of senior manager, in accordance with the provisions of Royal Decree 451/2012, of March 5, which regulates the

remuneration system for senior managers and executives in the public business sector and other entities.

This includes those that correspond to those who have left office when the budget year has already begun and during the time they have held the status of senior officer or senior manager. The same information must be published for instrumental entities.

This publication should consist of the statement of any income-generating activity, together with a statement of assets and of shareholdings in companies of all types. These statements must be recorded in the Register of Activities and in the Register of Assets. These obligations are stipulated in Law 7/1985, on Local Government.

Area C: Information on Planning and Evaluation

Indicator 8: Annual and multiannual plans and programmes, detailing specific objectives: activities, resources and estimated time required for goals to be achieved; degree of achievement and results: evaluation and periodic publication, together with the indicator and assessment parameters.

All of the local authority's plans and current programmes should be published. Plans and programmes are defined as documents, whatever their formal denomination, setting out the government's objectives, when:

1. They refer to operational objectives, i.e., specific, measurable objectives to be achieved as the result of an activity performed by the government agency in the exercise of its powers.
2. These documents have been approved pursuant to a legal instruction or in accordance with the decision of the competent body. A full list of such documents should be published and complete access to their content enabled.

A specific description should be published of the plans and programmes for activities or actions, and the means and resources needed for their implementation should be defined.

A series of indicators, identified within the plan itself, should be published. These indicators should enable the analyst to assess the degree of compliance of the actions to be carried out within the plan or programme.
