<b>Patient Information</b>	<b>5a</b>	De-identified patient specific information.	p.2, line 48-59
	<b>5b</b>	Primary concerns and symptoms of the patient.	p.2, line 48-59
	<b>5c</b>	Medical, family, and psycho-social history including relevant genetic information	p.2, line 48-59
	<b>5d</b>	Relevant past interventions with outcomes	
<b>Clinical Findings</b>	<b>6</b>	Describe significant physical examination (PE) and important clinical findings.	p.2, line 55-59
<b>Timeline</b>	<b>7</b>	Historical and current information from this episode of care organized as a timeline	✓
<b>Diagnostic Assessment</b>	<b>8a</b>	Diagnostic testing (such as PE, laboratory testing, imaging, surveys).	p.2, line 64-70
	<b>8b</b>	Diagnostic challenges (such as access to testing, financial, or cultural)	p.2, line 68
