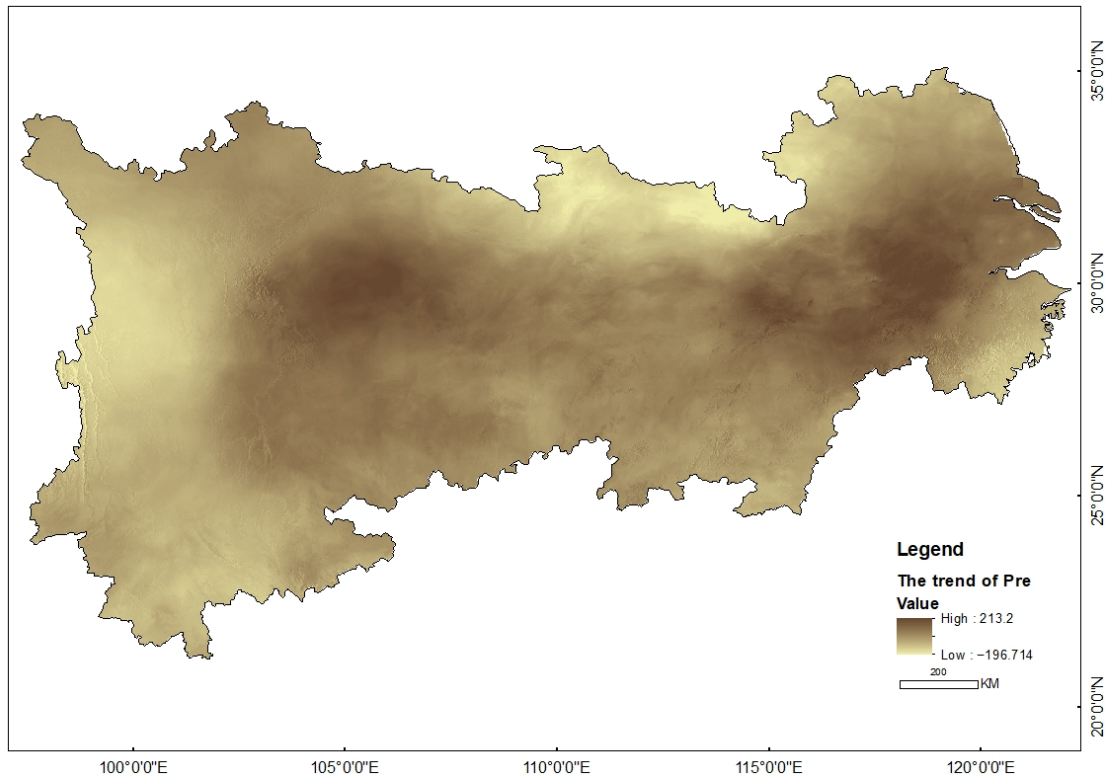


Figure S1. The trend of pre in the study area (2000-2020).

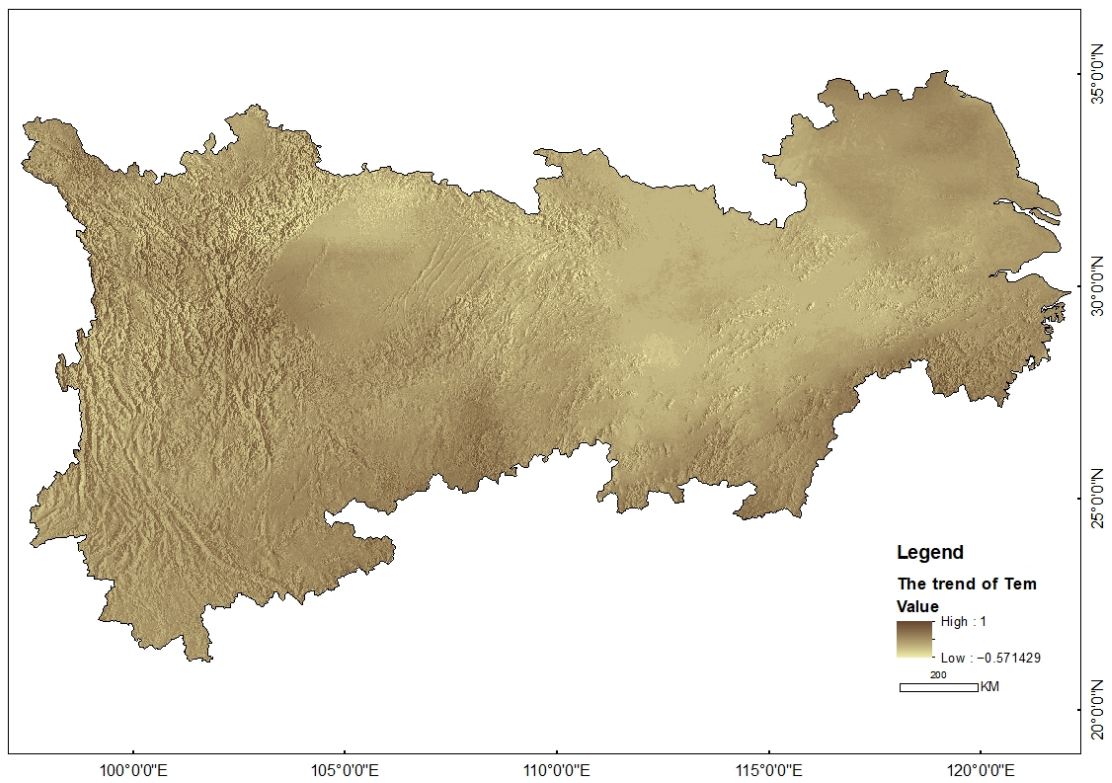


Figure S2. The trend of tem in the study area (2000-2020).

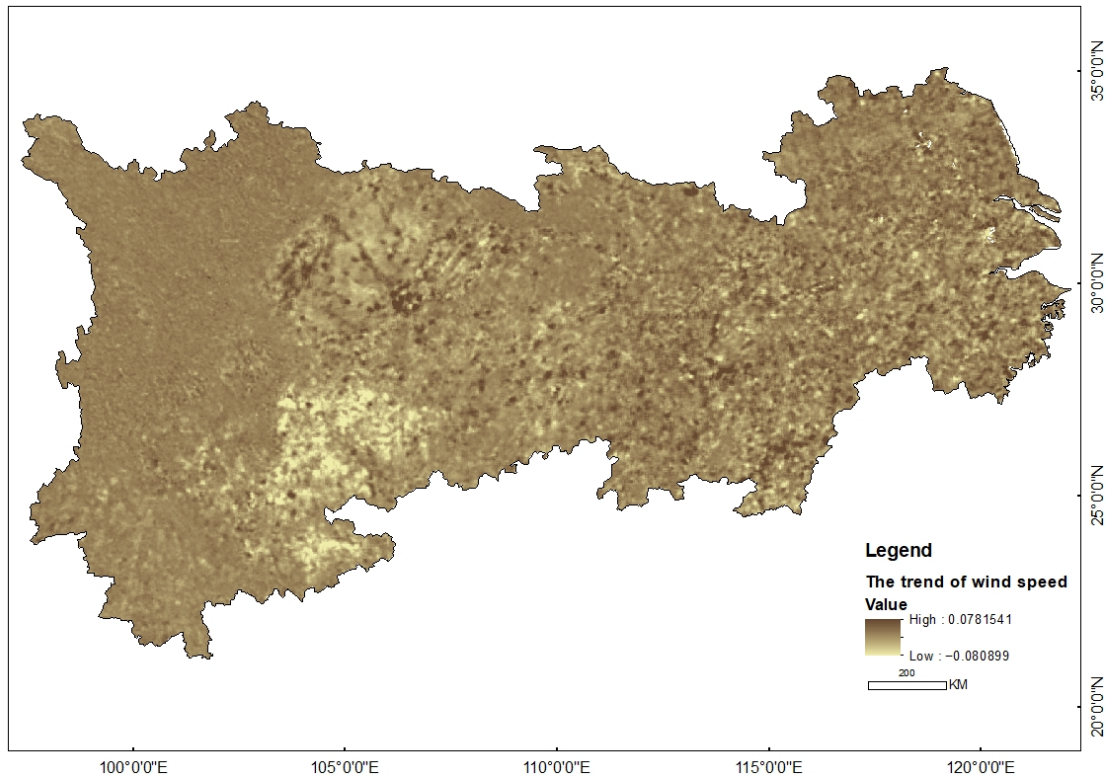


Figure S3. The trend of wind speed in the study area (2000-2020).

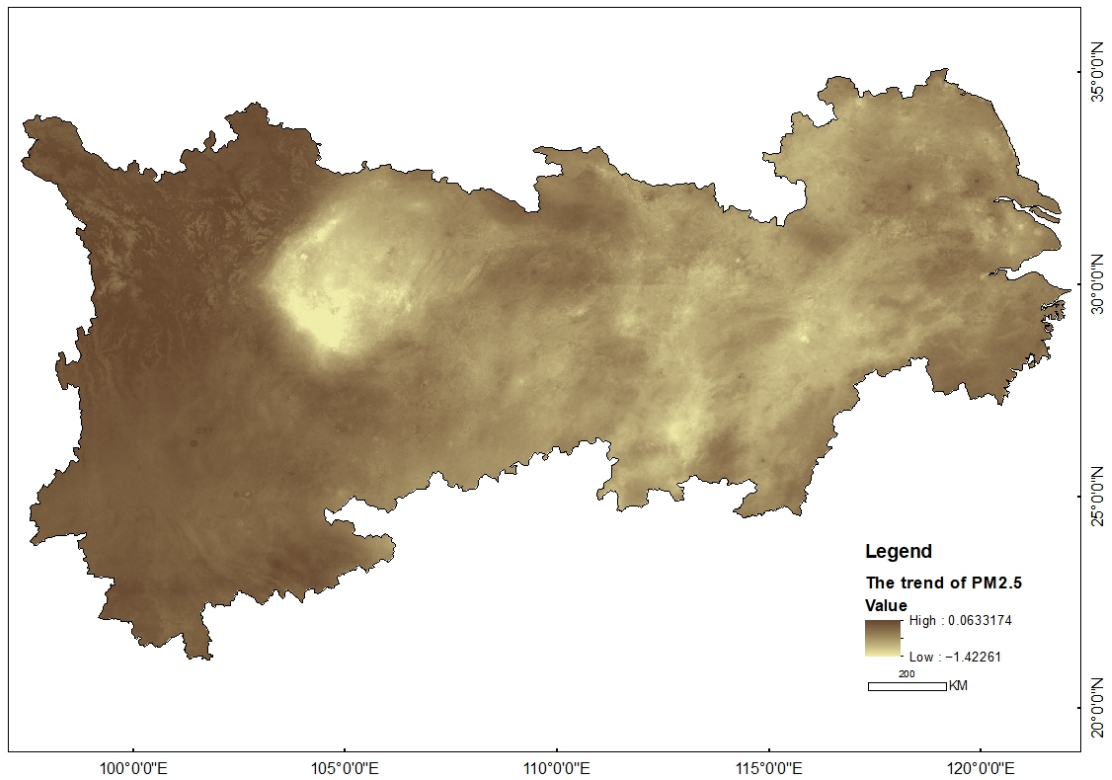


Figure S4. The trend of PM2.5 in the study area (2000-2020).

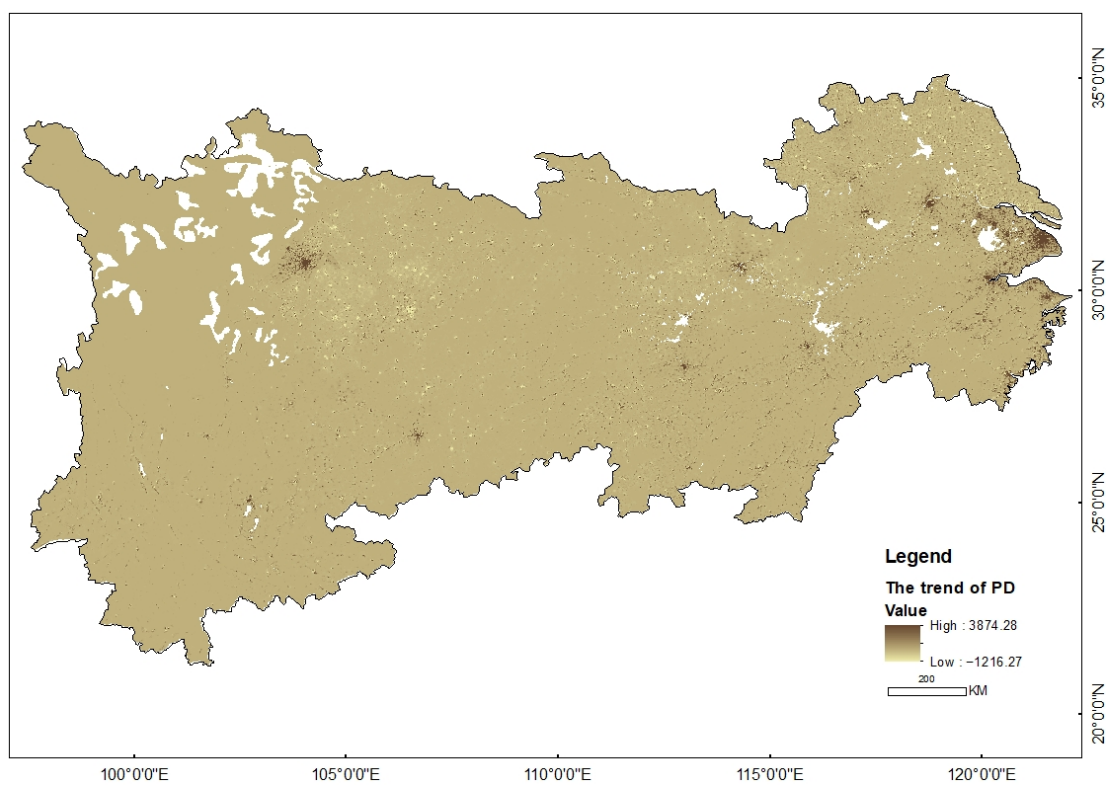


Figure S5. The trend of PD in the study area (2000-2020).

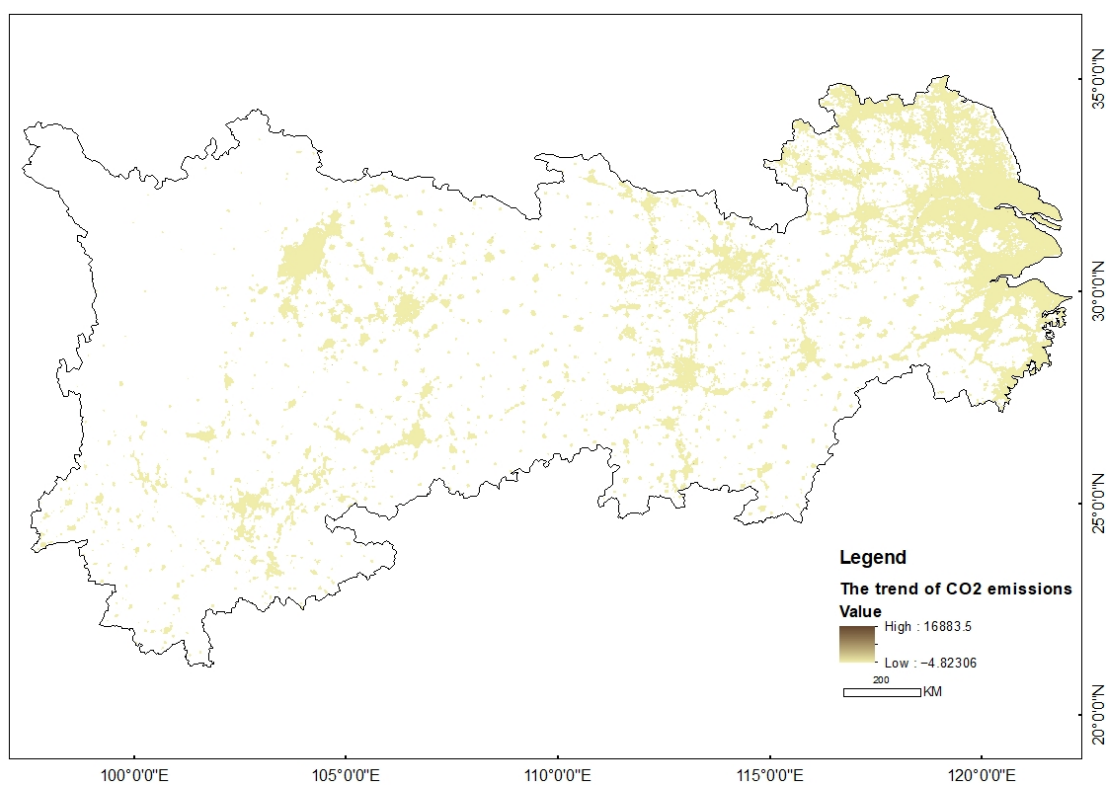


Figure S6. The trend of CO₂ emission in the study area (2000-2020).

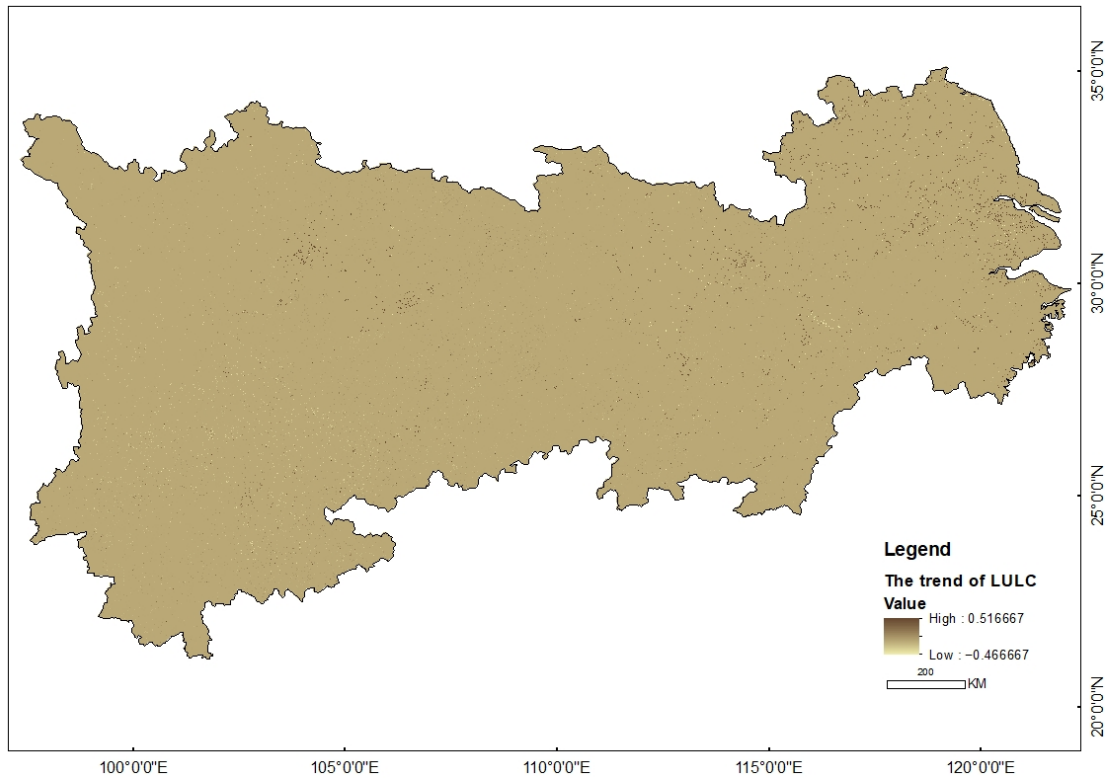


Figure S7. The trend of LULC in the study area (2000-2020).

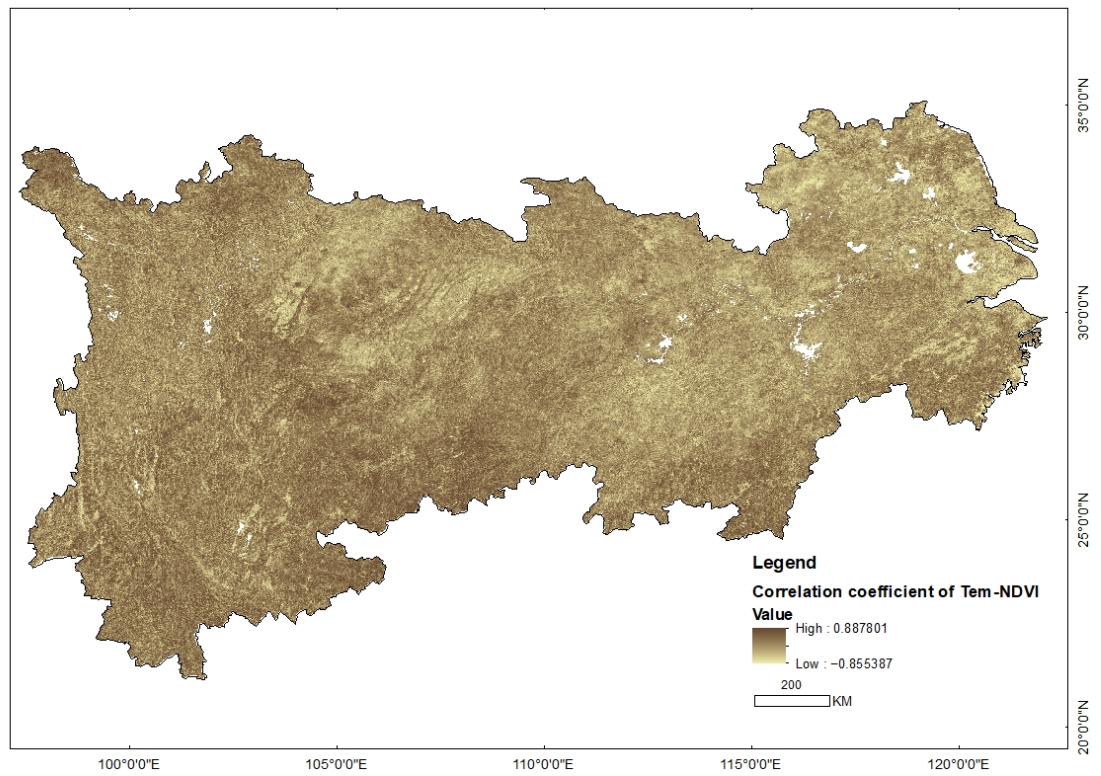


Figure S8. Correlation coefficients of tem-NDVI (2000-2020).

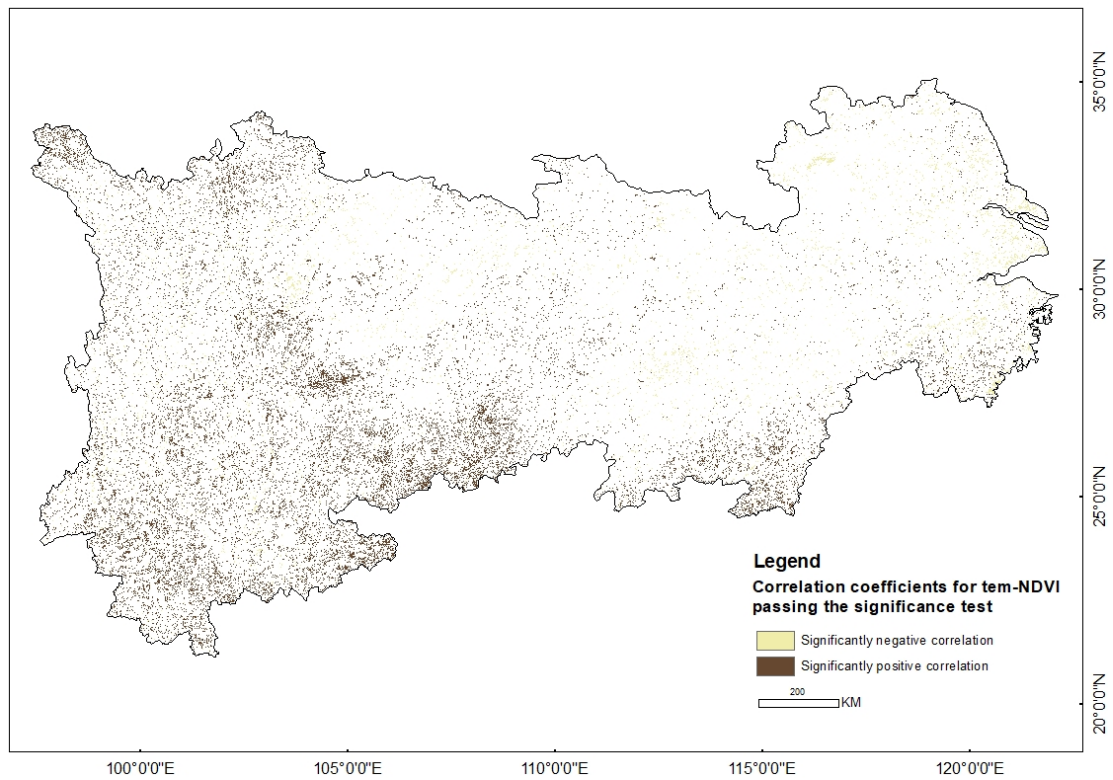


Figure S9. Correlation coefficients of tem-NDVI passing the significance test (2000-2020).

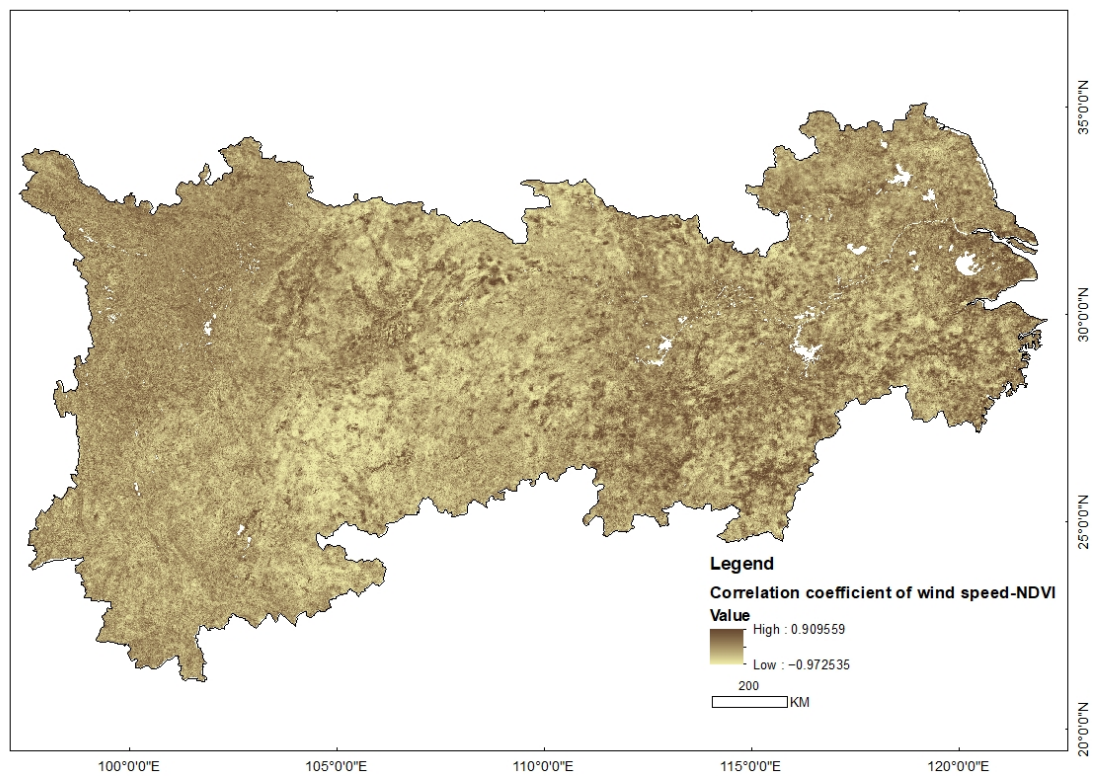


Figure S10. Correlation coefficients of wind speed-NDVI (2000-2020).

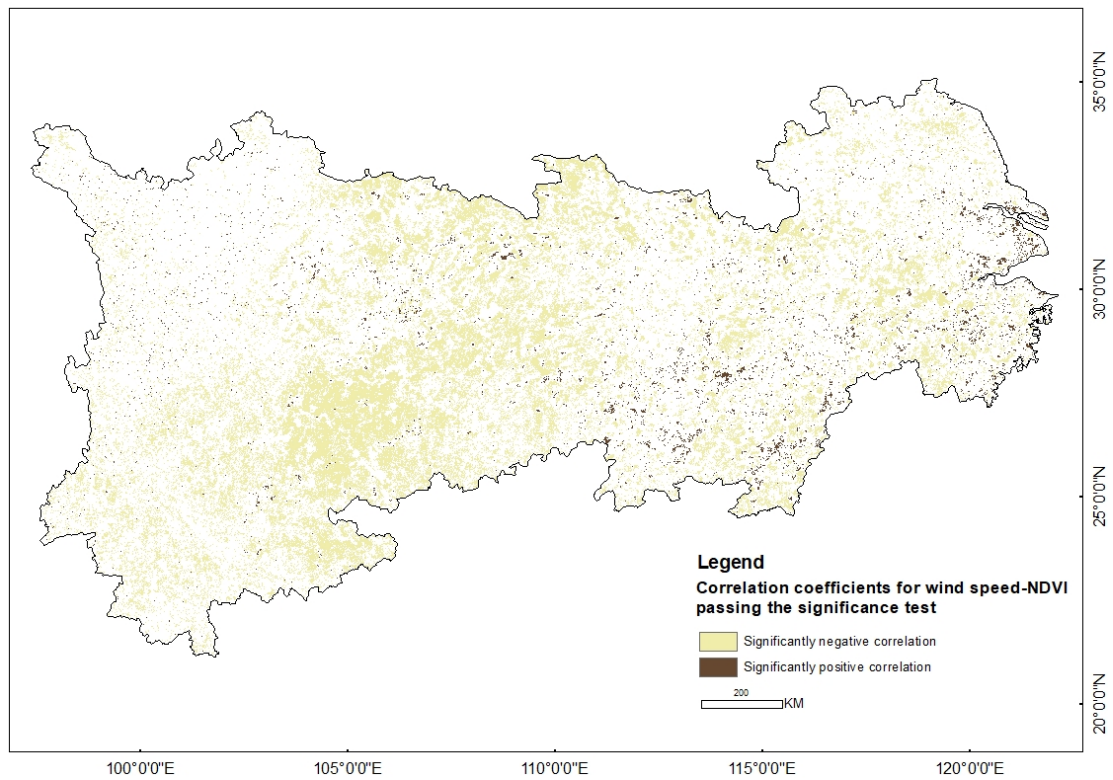


Figure S11. Correlation coefficients of wind speed-NDVI passing the significance test (2000-2020).

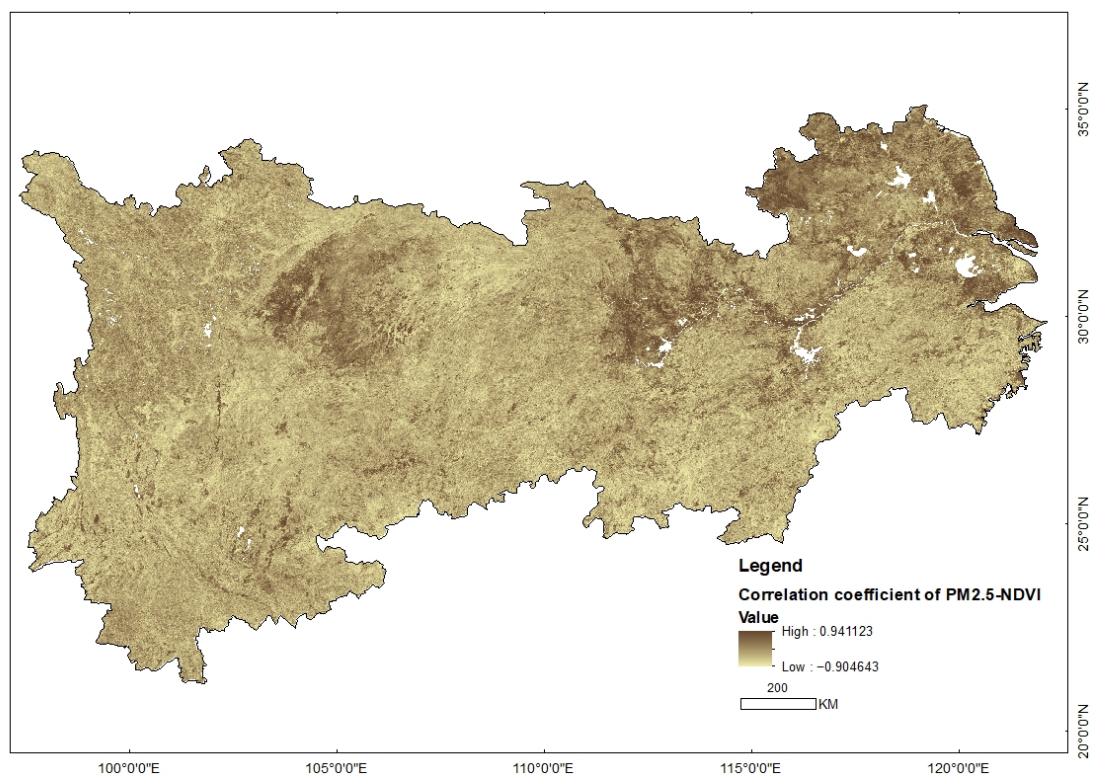


Figure S12. Correlation coefficients of PM2.5-NDVI (2000-2020).

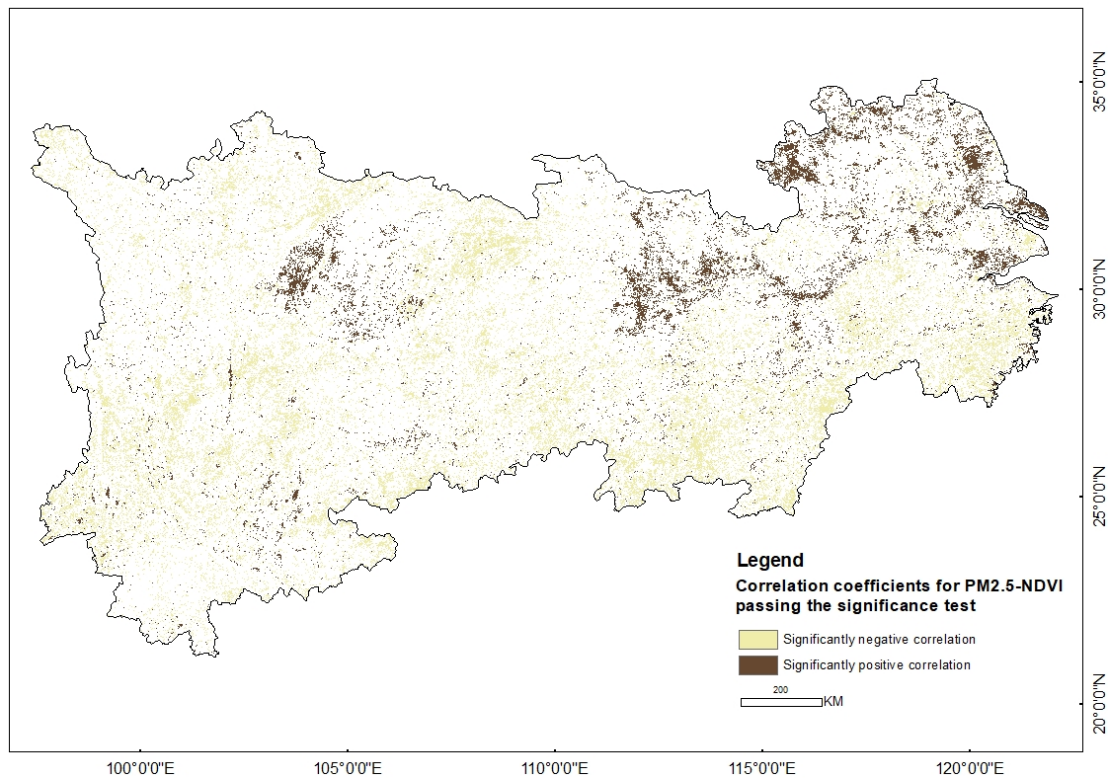


Figure S13. Correlation coefficients of PM2.5-NDVI passing the significance test (2000-2020).

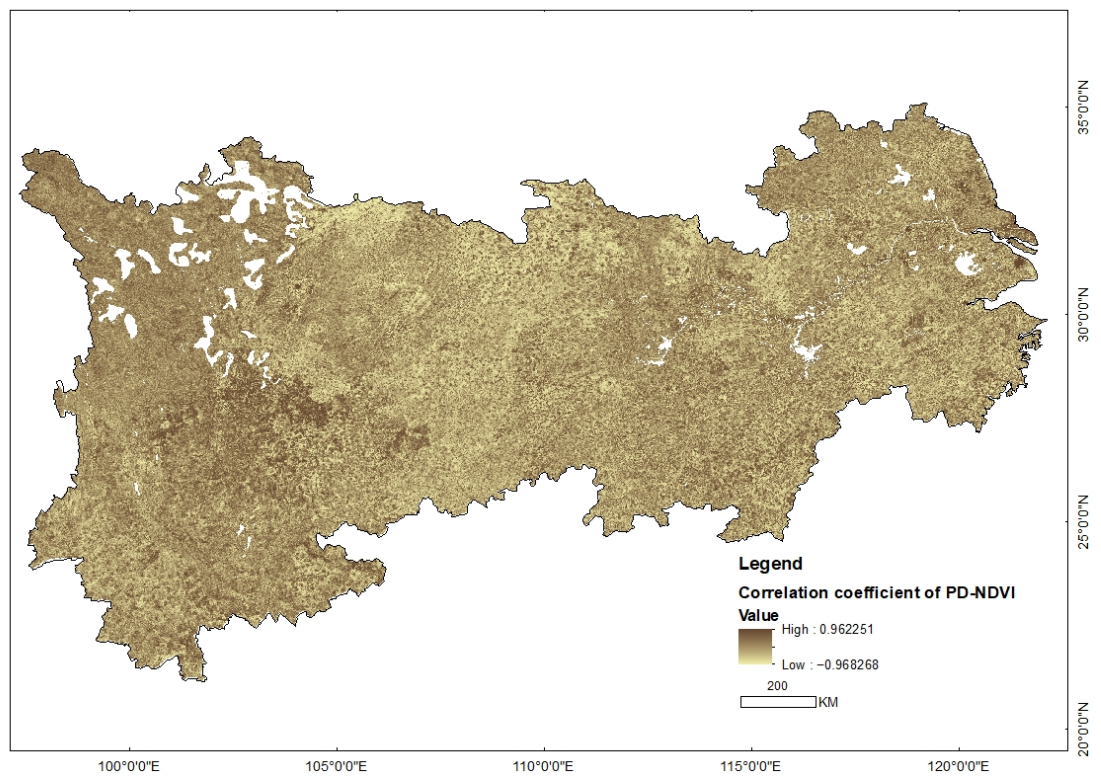


Figure S14. Correlation coefficients of PD-NDVI (2000-2020).

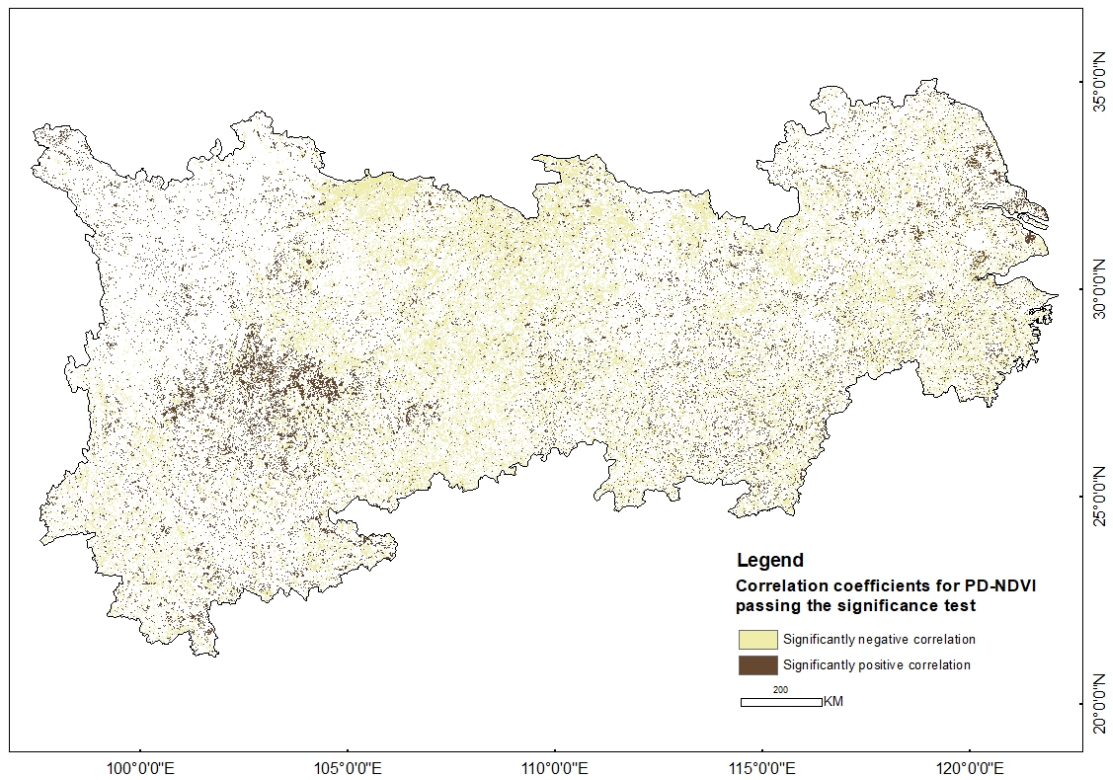


Figure S15. Correlation coefficients of PD-NDVI passing the significance test (2000-2020).

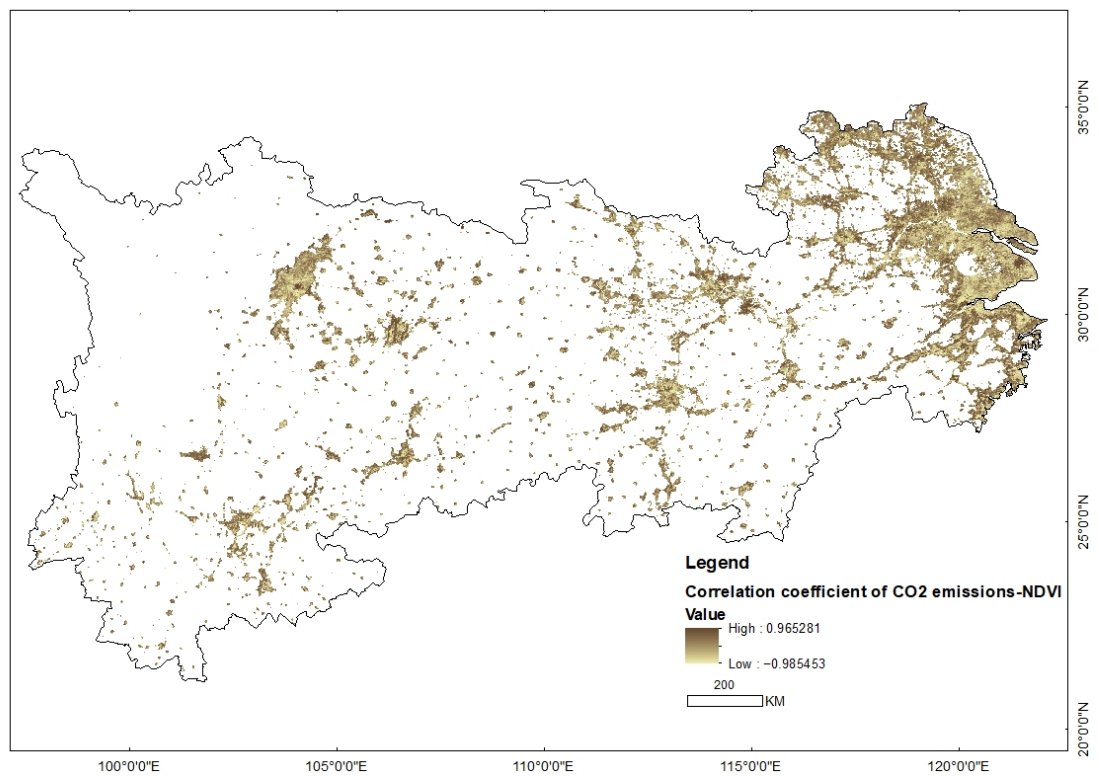


Figure S16. Correlation coefficients of CO₂ emissions -NDVI (2000-2020).

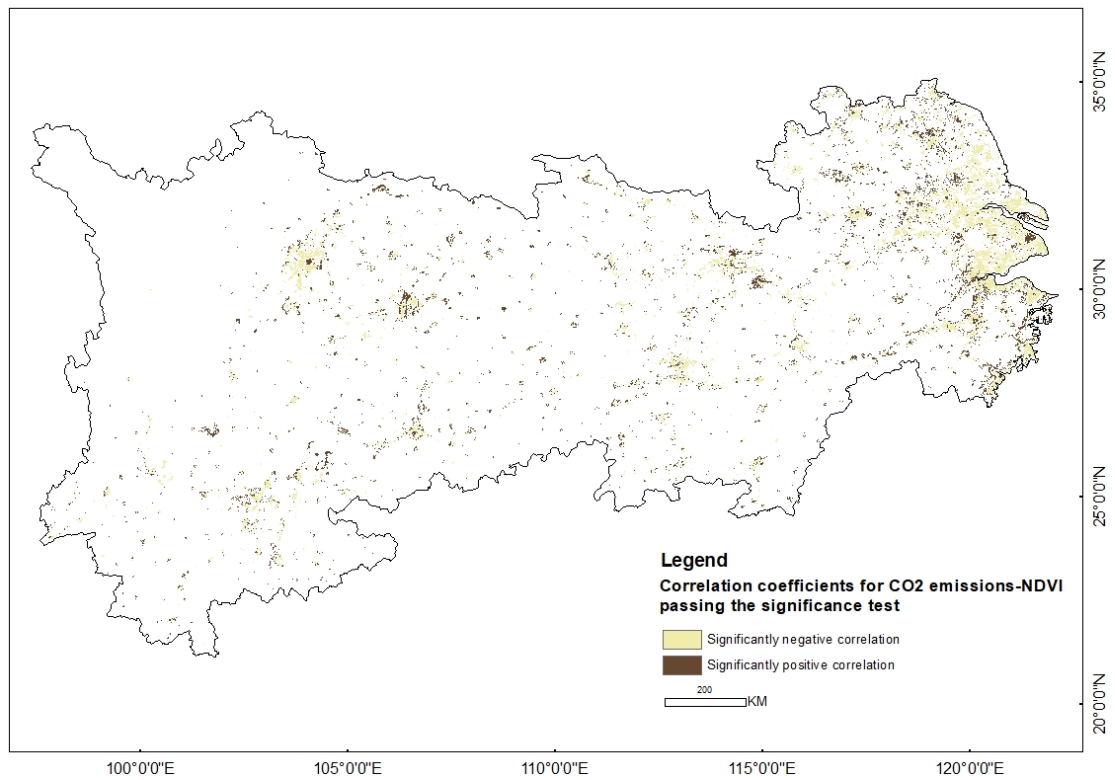


Figure S17. Correlation coefficients of CO₂ emissions -NDVI passing the significance test (2000-2020).

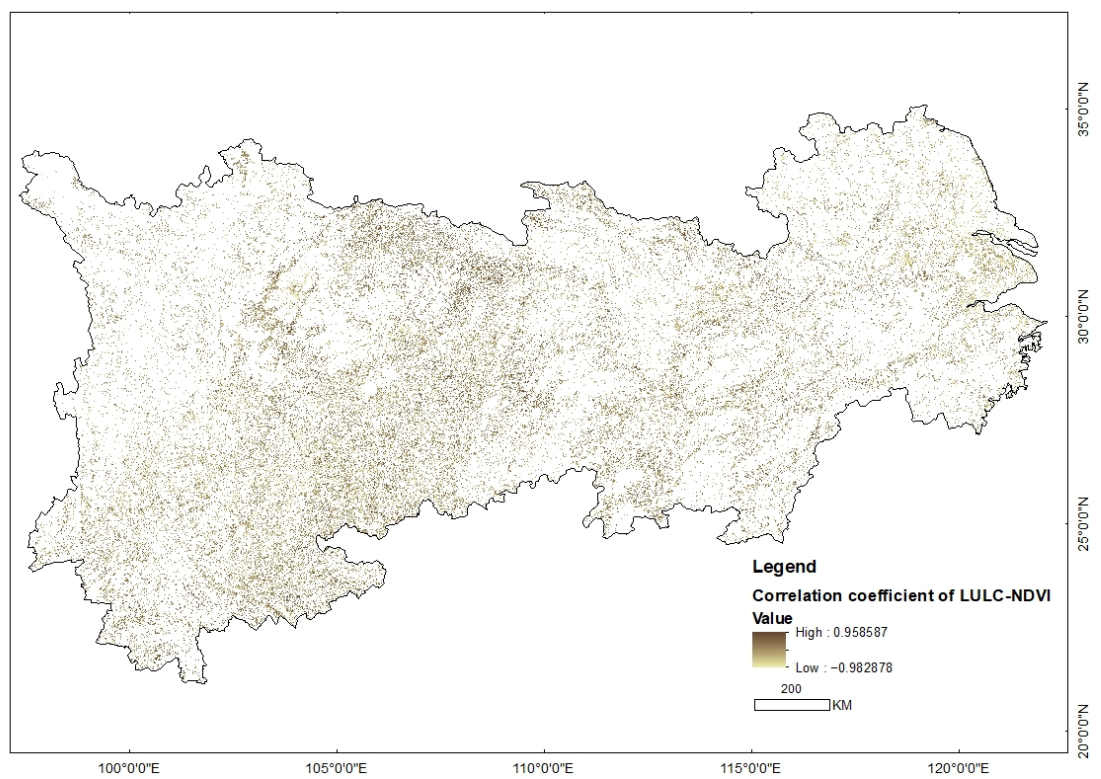


Figure S18. Correlation coefficients of LULC -NDVI (2000-2020).

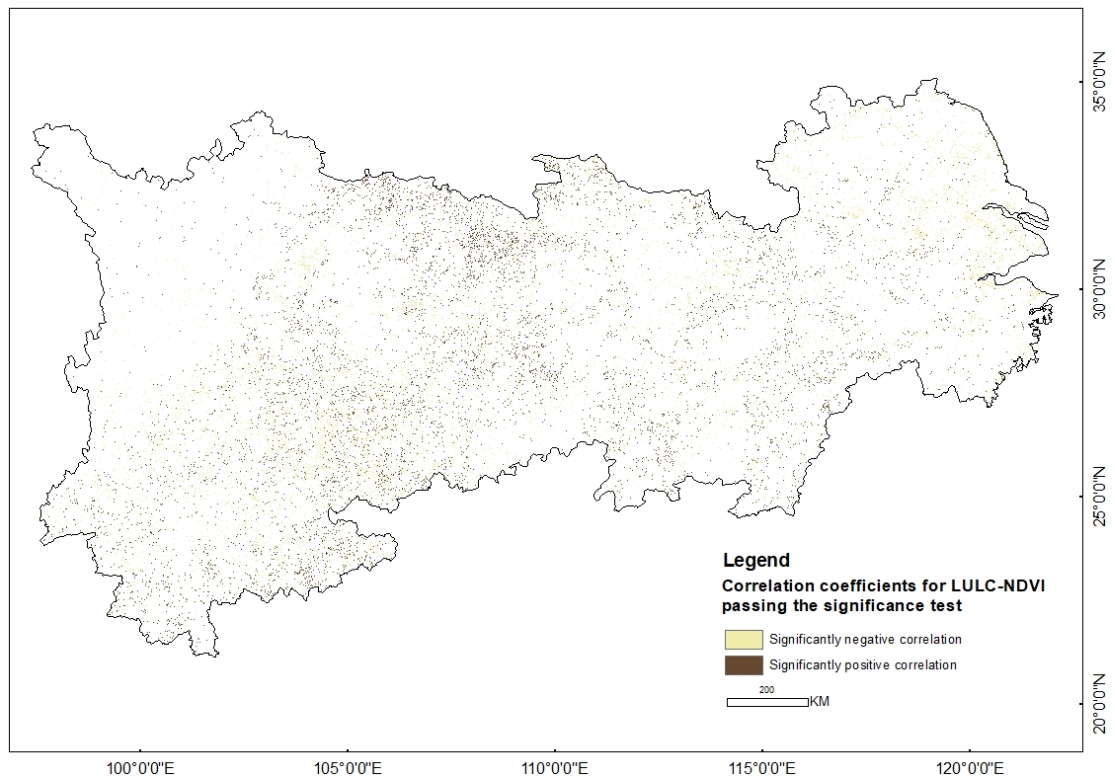


Figure S19. Correlation coefficients of LULC -NDVI passing the significance test (2000-2020).
