### Message from the Guest Editor

The importance of Andalusi art in its developmental stage, and in the evolution of Hispanic architecture, seems to be undeniable. At present, a large group of monuments and archaeological remains continue to remind us about that great period of history in the Iberian Peninsula (from the eighth to the fifteenth century). Fortunately, during the first half of the 20th century, some great historians and archaeologists, such as Leopoldo Torres Balbás, Henri Terrasse, or Manuel Gómez-Moreno, emphasized the importance of this period.
