### Message from the Guest Editor

Pregnant women with chronic conditions (e.g., nervous system, endocrine, genetic, infectious, immune, kidney, liver disease, hypertension, diabetes, mental and blood disorders), pregnancies at risk for pregnancy-related complications (e.g., preeclampsia, obesity, gestational diabetes, preterm labor, placenta previa and multiple pregnancies) and pregnancies with the fetus at risk (e.g., maternal diseases, genetic and chromosomal conditions, and growth restriction) are all encompassed by maternal–fetal medicine.
