Message from the Guest Editors

Disability rights advocates have expressed their concern that new care policies risk reinforcing outdated models that do not align with the international human rights law. Therefore, as countries start considering new systems, policies, and programs to address care gaps and inequalities, it is critical to integrate a disability perspective. This inclusion offers a better guide to developing holistic care and support systems that benefit everyone, from care workers to persons with disabilities.
