Interesting Images from the Sea

Message from the Collection Editors

Underwater photographers and aquarists produce many attractive pictures that may tell an interesting story. Most of these pictures are posted on websites and social media where they have little scientific relevance. They could also serve as basis for published observations in Diversity (as Interesting Images), which may lead to new scientific insights and hypotheses. Therefore, Diversity encourages the submission of such Interesting Images. No regular manuscript text (introduction/methods/results/discussion) should be included. Instead, they are treated as short notes with an abstract (max 100 words), a maximum of five keywords, and up to 15 references. There is no limit to the number of illustrations (which can be arranged as panels in Figures with captions), but they should all be relevant and of good quality. Video footage may be included as Electronic Supplementary Material. Image files can be included either in the template or uploaded separately in high resolution.
