Message from the Guest Editors

Meat is a highly consumed food, and its composition is highly dependent on the animal's diet. Feed composition influences not only the nutritional composition of meat but also its stability and sensory quality. This influence can be utilized during feed formulation in order to obtain meats with improved characteristics avoiding any detrimental effects on these parameters.

This Special Issue deals with the influence of feed composition on any aspect of meat quality (nutritional, sensory, stability and other physico-chemical properties), with special emphasis on novel feed ingredients such as insects and other new protein sources, agro-industry by-products, genetically modified plants, algae and new antioxidant extracts, among others. We aim at publishing review papers and innovative research results dealing with the effects on any physico-chemical parameter (proteins, fat, vitamins, mineral elements, tenderness), and sensory evaluation (including acceptability studies and chemical assessment). Studies dealing with innovative animal feeding approaches and state-of-the art analytical and data-treatment techniques (including omics approaches) are very welcome.
