Message from the Guest Editors

Contemporary European societies are now marked by unprecedented ethnic and racial diversity, driven by decades of migration and demographic changes. This Special Issue will explore how race and ethnicity intersect with social stratification and mobility in a "superdiverse" Europe, where immigrants, their descendants, and multiracial individuals face complex pathways to inclusion.

This Special Issue aims to explore the challenges faced by racial and ethnic minorities throughout Europe. By integrating these fields, we aim to present a comprehensive view of racialized social dynamics, connecting structural analysis with personal experiences and historical backgrounds.
