# Mixed Marriages in Europe and Beyond: 1945 to Brexit

### Message from the Guest Editors

The planned Special Issue of the journal *Genealogy* aims to trace these questions for the period after 1945, a period characterized by various migration and flight movements that can be linked to the end of the war, to labor migration, which became especially important in the 1960s, and to migrant groups seeking asylum since the 1980s. We welcome contributions that deal with these and related questions concerning politics, race and ethnicity, nationhood, affiliation, class, gender, sexuality, and cultural identity in historical development since the Second World War. An interdisciplinary perspective (drawing upon sociology, ethnology, communication and media studies, cultural, political and legal studies, etc.) would be especially welcome. We also seek contributions that treat trans-Atlantic and trans-Pacific connections as well as those that bring the global south, especially Africa, South America, and the Caribbean into the conversation.
