Message from the Guest Editors

This Special Issue of *Genealogy* invites submissions on the topic of “Familial Naming Practices” to examine ancestral naming and naming practices or patterns, specifically surnames. Surname can be used as an entry point to learning more about historical demographics and family make-up throughout the etymological family history. Manuscripts may focus on topics around identity and belonging in association with names, naming practices, and changing of names--particular surnames during immigration. Because the literature surrounding naming within genealogical and historical scopes is expansive, we are open to how authors frame the conversations around this special topic. Those who wish to submit to this special issue on names and naming should send a short statement of interest with a short description of the plans for the manuscript to the editors no later than October 1, 2018.
