Transnationalism is classically defined by anthropologists Basch, Glick Schiller, and Blanc-Szanton (1994, p. 7) as “the processes by which immigrants forge and sustain multi-stranded social relations that link together their societies of origin and settlement.” The goal of this issue is to examine the relationship between transnationalism and genealogy. The impact of transnationalism on family relations, family history, and family lineage across the globe is at the center of this issue. The editorial team hopes to attract contributions from a wide spectrum of disciplines or sub-disciplines with different theoretical perspectives and various methodological orientations that can broaden and strengthen the scope and depth of genealogical studies.
