# Health and Disease in Frail Older Individuals: Assessment and Management in Clinical Practice

### Message from the Guest Editors

Aging and frailty entail an increased risk of co-morbidity, diseases related to chronic inflammatory processes, and impaired physical and cognitive ability. Combined with the presentation of non-specific signs and symptoms, it is a challenge to detect deteriorating health in frail older people.

Precision medicine aims to provide care and treatment according to individual conditions and needs, and aims to deliver the most effective treatment for a given patient and thus improve the quality of care. To enhance the efficacy of precision medicine and health it is necessary to interpret vital parameters and biomarkers based on individuals' normal ranges. To detect changes in the health status of frail older people early on, there is an urgent need to clarify the ways in which vital parameters and biomarkers related to ageing and frailty might be interpreted. This Special Issue will focus on topics that are essential to improving the process of assessing the health condition of frail older people in clinical practice.
