Establishing the etiology and mechanisms of sports injuries is essential to the purpose and introduction of preventive measures, which may contribute to performance improvements in response to systematic and uninterrupted sports training programs. It is noteworthy that there are still gaps in knowledge about how the variables of exercise training intensity and volume could impact adherence to preventive programs, in addition to favorable physiological adaptations. Moreover, adopting better treatment methods is critical to optimize recovery processes and to reduce the long-term consequences of musculoskeletal injury.
