### Message from the Guest Editor

While clinicians are trained to save lives using technology and scientific developments to prevent death, prolonging life at the expense of patient suffering through nonbeneficial interventions is unacceptable. Unfortunately, this is prevalent in many healthcare systems today due to complex system and human issues. Nonbeneficial treatments are those medical interventions, medications, surgeries, and testing that will not make a difference to the prognosis of dying patients but can potentially harm them. It is time to reassess current approaches and welcome innovative ways to combat clinical inertia.
