Pelvic floor dysfunction hinders women's daily activities, inhibits their sexual function, negatively impacts their social and physical functions, and lowers their overall quality of life. PFD symptoms are widespread, affecting millions of women globally. In the US, around 25% of women have at least one pelvic floor disorder. However, because many women do not seek medical assistance and some are even reluctant to discuss PFD symptoms with their caregivers, it is still challenging to ascertain the actual prevalence of PFD.
