# Perceptions of Tobacco and Nicotine Products

### Message from the Guest Editors

Health behavior theories suggest that individuals' perceptions and beliefs about tobacco and nicotine products can play an important role in their use of these products. While perceptions about some tobacco and nicotine products may be relatively constant over time, others may be changing and/or evolving, potentially in response to new product regulations, innovations, information, and communications. Perceptions of newer products may influence whether or not people initiate or switch to these products. Tobacco and nicotine product perceptions can also be the targets of public health interventions. This special issue invites original research articles presenting quantitative and/or qualitative data about tobacco and nicotine product perceptions. This may include articles describing:

- Perceptions about new tobacco and nicotine products
- Changes in product perceptions over time
- Product perceptions among special population groups
- Methods for measuring product perceptions
- Comparative perceptions among products
- Associations between product perceptions and use
