# Current Clinical Treatments and Challenges for Heart Failure and Cardiogenic Shock

### Message from the Guest Editors

Heart failure and cardiogenic shock continue to be associated with significant morbidity and mortality, with a wide spectrum of etiologies and each patient presenting with peculiar characteristics. The aim of this work is to focus on contemporary drug management in the clinical scenario of cardiogenic shock, leveraging that on GDMT to further improve the outcomes of patients with severe heart failure. Led by an interdisciplinary team of experts, this Special Issue is open for submissions of original articles, reviews, and viewpoints focused on MCS and cardiogenic shock, with a specific focus on patients with heart failure. The areas of interest include but are not limited to the following: 1) hemodynamic adaptations after MCS; 2) identification of biventricular failure; 3) PCI strategies in MCS-supported patients with CS; and 4) perioperative optimization of high-risk patient candidates for heart replacement therapies.
