Message from the Guest Editors

The medical practice is moving toward precision medicine in the field of renal transplantation. Advancements in our understanding of the pathophysiology of graft rejection and other post-transplant complications have enabled the identification of implications in clinical features, the development of precise diagnostic methods and targeted therapies, and the accurate prediction of prognosis. Research on biomarkers has revealed new indicators for monitoring graft function and the early detection of rejection and subclinical graft inflammation. These biomarkers are being used as diagnostic tools and therapeutic targets, significantly improving post-transplant outcomes. All these efforts have improved the clinician's approach to diagnosis, treatment, and prognosis prediction in renal transplantation. The aim of this Special Issue is to highlight recent advances in the context of diagnosis, treatment, and prognosis prediction in renal transplantation, emphasizing how these developments are improving long-term outcomes for transplant recipients.
