# Endodontic Diseases: Prevalence, Risk Factors, and Treatment Outcomes

### Message from the Guest Editors

Endodontic therapy has undergone significant transformations over the last decades, evolving from traditional methods to incorporate advanced diagnostic tools and treatment options. However, it remains unclear whether this evolution has influenced the healing rate of endodontic disease. Systemic diseases (e.g., diabetes, MRONJ) may influence periapical health, warranting further study. While CBCT improves diagnostics, it may reveal previously undetected pathologies, altering perceived disease prevalence. Vital pulp therapy, utilizing new bioceramic materials, has enabled the preservation of tooth vitality in cases previously considered for root canal treatment.

Regenerative endodontic therapies for immature and mature teeth have emerged as a novel alternative for traditional endodontic therapy. Nevertheless, a thorough understanding of long-term treatment outcomes, especially in comparison to traditional treatment options, remains lacking. As we strive for innovation in this field, we encourage researchers to submit related papers for publication in the Journal of Clinical Medicine MDPI.
