Message from the Guest Editor

Rheumatoid arthritis remains a major clinical challenge due to its heterogeneous presentation, and risk of long-term functional impairment—although conventional, biologic, and targeted DMARDs may have transformed disease management, many patients continue to experience suboptimal control, adverse effects, or progression despite therapy. Research is currently focused on refining treatment precision by targeting distinct immunologic, cellular, and stromal pathways, and by integrating biomarkers that better predict therapeutic outcomes. This Special Issue aims to highlight advances in emerging biologics, targeted synthetic agents, and innovative approaches that modulate key inflammatory and tissue-destructive mechanisms in RA, and we welcome contributions from all clinical areas, including studies on novel pathways, real-world effectiveness, biomarker-based stratification, and strategies for managing difficult-to-treat disease and encourage researchers and clinicians to contribute their latest insights to advance the future of RA care.
