It is quite clear that clinical results achieved in restorative dentistry are due to personal clinical skills, but are also intricately linked to the continuous development of innovative materials. The integration of modern dental materials has undeniably propelled restorative dentistry towards unprecedented achievements. In recent years, the development and the introduction of new dental materials across restorative and prosthetic dentistry has been supported by effective in vitro pre-clinical research, but it has not always been paralleled by robust clinical research, resulting in clinicians encountering materials that may not necessarily outperform their predecessors.
