In recent years, there has been significant progress in the field of interventional cardiology from novel devices to appealing antithrombotic strategies. In addition, a substantial amount of new evidence on intravascular imaging techniques for guiding and optimizing percutaneous coronary interventions has strengthened recommendations and raised new questions. Similarly, multiple recent trials on percutaneous coronary intervention in patients with acute myocardial infarction and multivessel disease have enhanced our understanding on the prognostic value of myocardial revascularization completeness, timing, and guidance.
