Message from the Guest Editors

As we know, chronic pain and traumatic injuries in musculoskeletal disorders represent a significant and widespread health problem. In some cases, various surgical treatments are unavoidable and lead to various problems. Nevertheless, therapies based on emerging minimally invasive approaches, including infiltrations of drugs, substances, or medical devices, are showing promising results in pain management, improving functionality, and accelerating recovery. Among these, hyaluronic acid, collagen, polynucleotides, platelet-rich plasma, and corticosteroids certainly stand out. These procedures can often be assisted by ultrasound imaging in order to increase the loco-regional positioning of the treatment. This Special Issue aims to illustrate to the readers the updated evidence (also clinical experimental) and their consequent conservative clinical approach to the diagnosis and treatment of musculoskeletal disorders. This new evidence will be useful to raise awareness of the application of an appropriate conservative treatment. Original articles, systematic reviews, or meta-analyses are welcome.
