Thrombosis: Latest Advances and Prospects

Message from the Guest Editor

Thromboembolic disorders are among the leading causes of morbidity and mortality worldwide. Thrombosis is a result of a complex interaction between various inherited and acquired hypercoagulable states. The last almost two decades have seen significant advances and interest in this field. The recent COVID-19 pandemic, with its associated coagulopathy, caused a resurgence of interest in the thrombo-inflammatory pathway, while highlighting the need for better diagnostic and treatment approaches. The ongoing trials targeting FXIa inhibition offer a different approach to the treatment of thromboembolic disorders. Nevertheless, significant gaps still remain in our understanding of clot structure and causation, and there continues to be a need for improved diagnostic modalities and more effective and safer treatments, particularly in patients at high risk for thrombosis and bleeding complications. In this Special Issue, we invite submissions focusing on thromboembolic disorders. We welcome original research manuscripts, reviews, and articles. We look forward to receiving your submissions.
