Fractures of the Pelvis and Acetabulum: Novel Insights in Diagnostics and Treatment

Message from the Guest Editor

The journal JCM launched a Special Issue titled "Fractures of the Pelvis and Acetabulum: Novel Insights in Diagnostics and Treatment". Surgical management of pelvic and acetabulum fractures can be challenging. Nowadays, the majority of fractures of the pelvis and acetabulum occur in elderly patients after simple falls. Poor bone quality and frailty are complicating the management of these fractures. However, innovative instruments and anatomic implants have led to significant improvements in the treatment of pelvic and acetabulum fractures. New applications such as automated fracture detection, three-dimensional planning, surgical navigation, and additive manufacturing of surgical instruments are just the beginning of a digital revolution in pelvic and acetabulum fracture management. Prospective studies on patient-related outcome measurement (PROM) have to prove the superiority of these new applications. This Special Issue puts a spotlight on novel insights in diagnostics and treatment of fractures of the pelvis and the acetabulum.
