Innovations in Preeclampsia

Message from the Guest Editors

Simply stated, preeclampsia is new-onset hypertension with proteinuria during gestation. However, preeclampsia is complex, virtually affects every organ, and is often confused with other entities (e.g., exacerbation of chronic hypertension). Recent advances in diagnostic tools (e.g., FDA-approved analyte assays), understanding of preeclampsia, and new evidence regarding maternal care deserve communication in a Special Issue format. Aim and scope of the Issue: Our aim is to provide clinicians and scientists with a forum to communicate recent advances in the understanding of the pathophysiology, diagnosis, care, and prevention of preeclampsia. Submissions will be reviewed to tie in insights with numerous portals and pathophysiologic processes that lead to pre-eclampsia, hypertensive disorders of pregnancy, and imitators of preeclampsia (e.g., acute fatty liver, HELLP, TTP-HUS, SLE exacerbation). The scope of targeted papers includes contributions adding to the understanding, care, and prevention of preeclampsia as well as imitators of preeclampsia.
