Message from the Guest Editor

This Special Issue is dedicated to recent advances in gynecologic surgery. It focuses on the transition from meshes and slings to native tissues in pelvic reconstruction, female stress urinary incontinence, and a new era in cosmetic-plastic gynecology surgery aimed at eliminating or minimizing severe surgical complications. Such an approach requires significant changes in clinical care and research. Given the well-documented severe and life-threatening complications associated with using surgical meshes and slings, this Special Issue will provide timely information to better understand the indications for gynecologic treatments of various gynecologic conditions. It will serve dual purposes as a general evidence-based reference and will describe applicable new or traditional surgical gynecologic interventions for different site-specific defects. Additionally, this format will present newly discovered anatomical structures within the urogenital tract and conventional and surgical anatomy, since a surgical procedure cannot be adequately executed without appropriate knowledge of traditional and surgical anatomy.
