Message from the Guest Editor

One year later, the COVID-19 pandemic is still ongoing and the capacity of intensive care departments is one of the determinants of political decisions. However, many advances have been made in the care of ICU COVID-19 patients in one year, regarding specific drugs, the use of respiratory devices and respiratory settings, and the diagnosis and care of associated critical complications (e.g., neurological, cardiac, thromboembolic). Local and territorial organization, the protection of caregivers, the impact of sanitary protocols on the next-of-kin, and the impact of COVID-19 care on the other usual critical care pathologies are also crucial questions. The typology and prognosis of patients have also changed in the course of one year. This Special Issue aims to describe these physiopathological, diagnostic, and therapeutic advances in the specific population of critically ill patients.
