Message from the Guest Editors

Older adults represent a large portion of patients with acute coronary syndromes, and with cardiovascular diseases in general. Nonetheless, they are seldom included in randomized clinical trials, and therefore evidence to guide clinical decision making is often not generalizable to them. This is a problem with everyday clinical implications worldwide, and often results in the mis- or undertreatment of this large population of fragile individuals. In this Special Issue of the *Journal of Clinical Medicine*, we aim to publish high-quality, scientifically robust studies that will enrich the literature on this topic, with special attention to areas with clinical implications and where little or no evidence is available. We believe that such papers will be useful and instructive, and that they and will stimulate scientific discussion and advancement in this field.
