Message from the Guest Editors

The fields of pediatric neurology and psychiatry are increasingly overlapping, supported by new insights in unravelling the underpinning mechanisms of neurodevelopmental disorders. Although central nervous system plasticity is now better understood. neurological and psychiatric treatments for children remain scarce, and few affordable disruptive therapeutic options has emerged so far. Paradoxically, children are often better and sooner diagnosed, with few available treatment options besides rehabilitation. Nevertheless, many drugs are allowed to be administered after twelve years of age and have significant side effects, with longterm consequences requiring time to be properly assessed. Brain plasticity is maximal during early childhood, but this therapeutic window is not long enough to take advantage of. This Special Issue aims at gathering nonpharmacological innovative therapeutics able to improve the prognosis and quality of life of children with neurodevelopmental disorders, based on a combination of original research and review papers.
