As many of you already know, Degenerative Cervical Myelopathy (DCM) is the most common cause of spinal cord impairment in the developed world, leading not only to a decrease in the quality of life of those affected but also to a growing healthcare burden. Over the past few years, a number of multicentre studies on the topic have emerged, helping to provide a better understanding of the condition. However, it is also clear that much remains to be learned. This is evidenced by the fact that the term DCM was only formally introduced in 2015, guidelines on DCM based on the GRADE process were published in 2017, and, at the present time, an active effort called RECODE-DCM is underway that is aims to shape the way future DCM research is carried out. With this Special Issue, we hope to encourage submissions that discuss the current stateof-the-art, address ongoing knowledge gaps, and focus on ongoing controversies related to Degenerative Cervical Myelopathy and the management of the aging spine.
