Message from the Guest Editors

This Special Issue aims to explore the still open areas of septic disease management, we would like to focus attention on how fluid management and the severity of endothelial damage can modify the global therapeutic approach and on what tools we can have available to guide the therapeutic management itself. The main areas of interest in this Special Issue include, but are not limited to:

- Analysis of how the endothelium and its dysfunction influence the course of sepsis;
- Evaluation of how fluid management over time in the septic patient modifies the prognosis;
- Survey of the tools currently available for monitoring endothelial dysfunction or microcirculatory condition in the septic patient;
- Analysis of the influence of sepsis coagulopathy in the different phenotypes of the septic patient and how this variability is associated with endothelial dysfunction.
