### Message from the Guest Editors

Managing vascular aneurysms throughout history is a testament to curiosity, humility, tenacity, and innovation within medicine. Early Egyptian documentation, as far back as 1550 B.C, notes “tumors of the arteries” that are incurable without “magic”. Tenacious early surgeons, such as Dr. Vorhees in 1952, attempted packing, ligation, wrapping, and eventually interposition grafting. This led us to modern open aneurysm repair and focusing on developing better artificial conduits. The 20th century brought about further innovations with the advent of endovascular aortic aneurysm repair.
