Message from the Guest Editors

Thrombosis and haemostasis disorders remain major contributors to global morbidity and mortality, with ongoing challenges in optimizing prevention, diagnosis, and management across diverse patient populations. Despite therapeutic advances, key clinical dilemmas persist—particularly in complex scenarios such as pregnancy, pediatrics, malignancy, and antiphospholipid syndrome. Moreover, the development of safer, more effective antithrombotic regimens tailored to individual risk profiles is urgently needed. At the same time, innovations in artificial intelligence, digital health tools, and biomedical devices are opening new frontiers in thrombosis care—from personalized risk prediction to real-time monitoring and clinical decision support.
