Message from the Guest Editor

Psoriasis is a chronic immune-mediated inflammatory skin disease with a prevalence of 2–3% worldwide. Although the diagnosis of psoriasis is usually straightforward, sometimes it may be difficult and challenging. In addition, no established diagnostic criteria exist for the diagnosis of cutaneous psoriasis. Psoriasis has been classically classified on the basis of age of onset, severity, topography and morphologic evaluation. Regarding the management, psoriasis can be optimally controlled today. In spite of newly developed treatments, current challenges address difficult-to-treat areas, especially the palmoplantar areas and the presence of associated diseases, in particular oncological comorbidities. Therefore, the clinician is fully involved in providing the optimal therapeutic strategy and reducing the disease progression also in difficult-to-treat clinical scenarios. This Special Issue aims to highlight the challenges in diagnosis and the most effective treatment strategies for psoriasis care.
