Message from the Guest Editor

While the progress in endodontics and traumatology is remarkable, various recent treatment methods, materials, and imaging approaches await thorough evaluation to fully elucidate their benefits for patients of all ages. In particular, regenerative and minimally invasive treatment options, along with possibilities to preserve pulp tissue, may facilitate better lifelong outcomes. Research on biocompatible and effective materials—especially those with antimicrobial and anti-inflammatory properties and those concerning density and stability at the interfaces between the pulp and the respective hard tissues—is of utmost importance.

Advanced in vitro models and imaging are just as crucial as well-designed clinical studies and efforts to gather big data to collaboratively gain deeper insights using artificial intelligence applications. Finally, action is needed to broaden worldwide recognition and the actual application of these specific techniques, beginning with enhanced educational efforts for undergraduate and postgraduate students.
