Knee arthroplasty is already an effective treatment to relieve pain and improve mobility for severe osteoarthritis. The aim is now to further improve patient satisfaction and functional outcomes. So far, despite good survival rates, up to 20% of total knee arthroplasty patients remain dissatisfied. Recently, promising new technologies have been developed to improve surgical accuracy, and the hope is that if we place the implant perfectly, we maximize the odds that our patient will have excellent results.
