Message from the Guest Editor

Neurological diseases are the result of neurodegenerative processes, neuroinflammation and/or physical trauma to the central or peripheral nervous system. Patients affected by neurological diseases frequently develop comorbidities like motor impairment and neuropathic pain, which can be more debilitating than the primary neurological condition. Whilst understanding the aetiology of the neurological disease is imperative, clarifying the pathophysiological mechanisms of the associated comorbidities is progressively becoming a prioritized area. Exploring the mechanisms underlying the associated motor and sensorial dysfunctions represents a unique opportunity to gain new insights on the neurological disease, and may be the next logical step for the development of more effective therapeutical strategies. In this Special Issue, authors are encouraged to submit original research papers and/or current reviews focused on the pathophysiological mechanisms of motor impairment and/or neuropathic pain in neurological diseases and on currently available treatment options.
