Message from the Guest Editors

The conservation of medicinal plants in botanical gardens has become a very important topic in recent years due to its great significance for pharmacology and ethnopharmacology. Medicinal plants can help researchers and students of plant pharmacology and biology to learn about their anatomy and morphology, discover new compounds with therapeutic potential, and find out about local species that are traditionally used for medicinal purposes, which is the subject of ethnopharmacology, etc. Additionally, the conservation of medicinal plants in botanical gardens allow visitors to find out about plants' medicinal potential.
