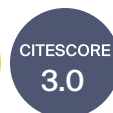

This Special Issue on advancing restorative justice in criminal justice settings and beyond. There is no denying that restorative justice has developed as both a movement and as a philosophy designed to give victims a stronger voice in the criminal process, to solve problems and to provide a forum by which conflicting parties are brought together.
