Message from the Guest Editor

Eating disorders are serious psychiatric illnesses characterized by severe disturbances in eating behaviors and associated cognitive features. The main phenotypes are anorexia nervosa, bulimia nervosa, and binge eating disorder. These disorders have significant psychiatric comorbidity and medical morbidity and mortality if untreated. Ongoing research aims to elucidate disease mechanisms, identify risk factors, develop novel treatments, and ultimately improve the prognosis of these disorders. Subtopics:
