# Assessment of Vitamin D Status and Intake in Human Health

### Message from the Guest Editor

Vitamin D deficiency has a high prevalence worldwide. The heterogeneity of nutritional and clinical VD guidelines is the most challenging. As the VD receptor is expressed in most human cells, it has been proposed that VD may have a more widespread role in general health. Several experimental and epidemiological studies support this. The general dilemma regarding the potential extra-skeletal health benefits of VD is that the VD requirements for skeletal health may be fulfilled at lower or higher 25(OH)D concentrations than the requirements for certain extra-skeletal health benefits. This Special Issue will include manuscripts that focus on assessing vitamin D status and investigating the associations or causal relationships with any health benefit or disease outcome. Additionally, we accept studies regarding investigating vitamin D supplementation in healthy individuals or in patient populations with vitamin D deficiency compared to those of normal vitamin D status.
