# Urban Governance of Interreligious Dialogue and Freedom of/from Religion

### Message from the Guest Editors

This Special Issue invites social scientists to contribute to the analysis of inter-religious dialogue through the lens of two analytical approaches. The first focuses on the role of inter-religious dialogue in the urban governance of religious diversity. The second concentrates on inter-religious dialogue as a social practice of freedom of/from religion. We invite authors wishing to contribute to this Special Issue to consider the following topics for their potential contributions: The role of local municipalities and religious/secular stakeholders in negotiating policy instruments for governing religious diversity in cities.

Inter-religious dialogue and forms of public religious/secular expressions.

Urban histories, social hostilities, and initiatives of inter-religious dialogue.

Inter-religious dialogue and societal meanings of freedom of/from religion.

Social representations of inter-religious dialogue within media discourses and citizens' attitudes toward religious diversity.
